

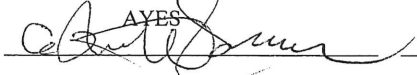
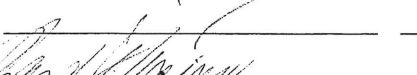
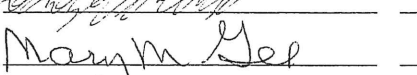
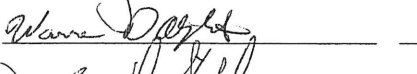
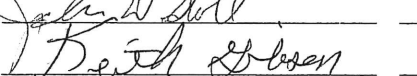
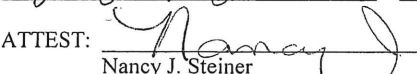
ADDITIONAL APPROPRIATION ORDINANCE

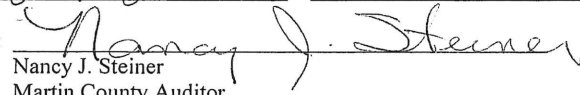
WHEREAS, it has been determined that it is now necessary to appropriate more money than was appropriated in the annual budget; Now, therefore:

I request the following additional appropriations from the General Fund:

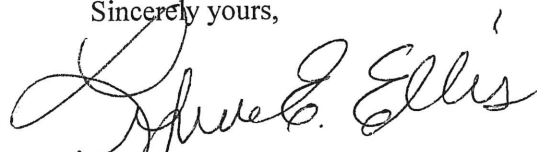

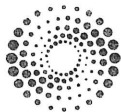
Attached is a copy of the correspondence received from Thomson Reuters denying CPO Lisa Brittain's request to cancel the subscription.
