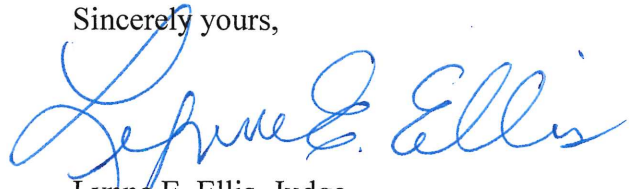
Re: Request for Additional Appropriations
