

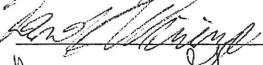
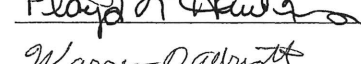
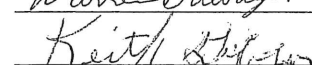
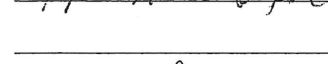
ADDITIONAL APPROPRIATION ORDINANCE

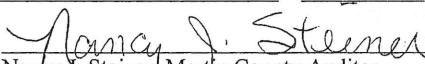
WHEREAS, it has been determined that it is now necessary to appropriate more money than was appropriated in the annual budget; Now, therefore:

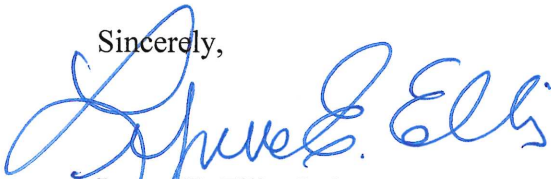

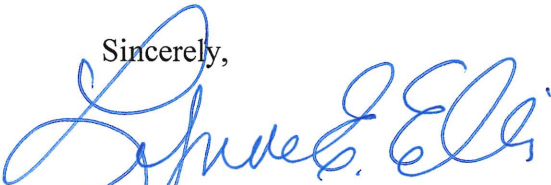
Re: Request for Additional Appropriations

AGREEMENT FOR SERVICES

THIS AGREEMENT entered in the 13th day of March, 2012, by and between the Martin County Health Board (hereinafter referred to as "Martin County Health Department") and Hoosier Uplands Economic Development Corporation (Hereinafter referred to as "HUEDC");

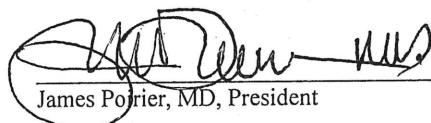

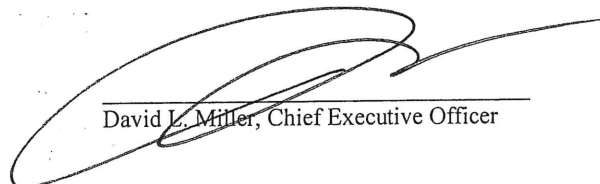

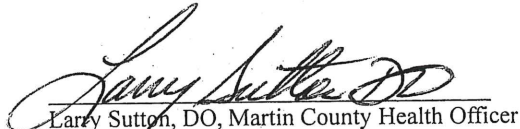
