WHEREAS, Clyde Hawkins did depart this life on May 12, 2016, and;

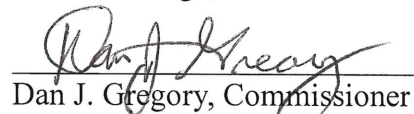
