Press Release RE: Monroe County Property Taxes due November 10th

This press release is to share payment options with the taxpayers as the fall due date approaches. The entire courthouse building at 100 W Kirkwood Avenue is closed to the public. All offices in the courthouse are open by appointment. The Treasurer's Office will continue to serve taxpayers during the COVID-19 outbreak.

Tax bills were mailed April 1st, 2020. To get a copy of your tax bill online visit our website www.co.monroe.in.us/treasurer. Click on "View Property Tax Info". Search for you property and click "View Tax Bill". Taxpayers can also email us to request a copy of their tax bill at treasurer@co.monroe.in.us.

Taxpayers can pay their taxes by these options listed below. Include a self-addressed stamped envelope for a receipt.

1. Mail to PO Box 2028, Bloomington, IN 47402. FedEx or UPS to 100 West Kirkwood Ave Rm 204 Bloomington IN 47404. Include a self-addressed stamped envelope for a receipt. All payments received by mail **must** be postmarked by November 10.
2. Pay online by e-check (\$1.50), credit or debit card (\$3.95 or 2.45%) or by phone using the same card options.
 - a. www.co.monroe.in.us. Click "Online Tax Payment." Call 1-877-690-3729. Use Monroe County Jurisdiction Code 2410
3. Payment drop box located at the north doors of the Courthouse. Include a self-addressed stamped envelope for a receipt.
4. Drop off payment at one of 3 local bank branches collecting on our behalf. First Financial Bank (2 branches) and Farmers and Mechanics Savings and Loan (3535 W 3rd St, Bloomington IN).
5. For an appointment call our office at 812-349-2550. Phones are very busy during tax season. If you leave a voicemail, it will be returned in the order it was received.

To monitor your payment, please make use of our online tax portal. It is available from our website www.co.monroe.in.us/treasurer. Click on "View Property Tax Info". You can see payments made in past years, payments applied this year, and current taxes due.
