Jackie Knafel, County Coordinator, closed the 2022 Council year with no unfinished business being before the council.

Jackie Knafel, County Coordinator, opened the 2023 Council year with the election of the president of the board. Mary Wysong made a motion to nominate George Bennett for President of the Noble County Council. Tom Janes seconded the motion. Motion carried. Doug Harp moved to close the nomination with a second coming from Tom Janes. Motion carried. George Bennett was elected President of the County Council with 6-0 vote with George Bennett abstaining. Doug Harp nominated Mary Wysong for the office of Vice President. Tom Janes seconded. Nominations closed and Mary Wysong was elected Vice-President of the County Council with a 6-0 vote. Mary Wysong abstained.

### **MINUTES**

Minutes of the previous meeting were read and approved as written with a motion from Doug Harp. Mary Wysong seconded and the motion carried 4-0 with the new member abstaining from vote.

# **COMMITTEE REPORTS**

The Northeastern Fiscal Year 2022 report was shared with the council.

# HIGHWAY

Richard Rogers, Highway Superintendent, had the following construction update for the Council:

- The department is cleaning up after the recent snow storm
- The department is currently down 2 drivers and a brush person.
- A safety check list is in place for all drivers and was reviewed
- Training sessions are scheduled for various pieces of equipment and highway operations.

Zack Smith, Highway Engineer, has the following engineering update:

- Community Crossing grant projects for this \$1,000,000.00 grant have been submitted. This
  would be for overlay projects in the Northeast part of the county. Zack is hoping to be notified
  of the award by April. A Financial Commitment letter was prepared by Zack for signing.
  Motion to sign the letter came from Doug Harp. Mary Wysong seconded and the motion
  carried 7-0.
- LPA projects FY 2028 Zack has submitted 3 LPA project to the state. Bridge 61, Baseline Rd from 600 E to 800 E and 100 N at 50 W for the Safety project. Zack will do the presentations for these projects to INDOT on January 19, 2023.

• Zack talked to the council about a program for No-Passing Zone Study with mobile mapping. This would cost the county approximately \$54000.00 the first year with \$40,000 + the next two years. Zack is thinking this program will be usable by other departments as well. This is a 3-year contract that the commissioners have agreed to. Zack indicated that there will be an additional coming before the council at their February meeting for this very purpose.

#### **NEW ANNEX**

Zack Smith, Project Manager, advised the council that the new annex project is close to being closed out. There are still some furniture issues to resolve and the acoustic paneling issue is still in the works. The water softener project for the cold water should be done by the end of January.

#### **COURTHOUSE RENOVATION**

Zack Smith, Project Manager, is reporting that the project is moving along with funding options being studied and evaluated. ARP money as well as CEDIT for the furniture and equipment and Rainy Day for relocation costs as well as some design and engineering costs may be options for some of the funding. Zack explained to the new members of the council that this project will consist of Mechanical and electrical improvements as well as office space and modification of the entrance. There will be additional restrooms and improvement to the courts.

#### **CCD FUND**

Noble County Sheriff, Max Weber, was present for the following update from his department:

- Max informed the council that the improvements to the jail are coming along on schedule.
   Roofing repair, Boiler repairs, new grinders and mechanical and lighting are all a part of this projects using ARP money for the funding.
- Max has a "memorandum of understanding" for the commissary fund. Motion to sign the memorandum came from Doug Harp. Tom Janes seconded and the motion carried 7-0.
- Max is reporting 15 inmates in the work release program which about the maximum amount due to tracking and management of the program.
- Max did not report the amount of Federal inmates now at the jail but is getting \$70.00 a day for their expenses.
