# MINUTES OF A REGULAR SESSION OF THE BOARD OF COMMISSIONERS HELD December 19, 2016

Comes now the hour of 9:55 A.M. on the 19<sup>th</sup> day of December, 2016, in the Commissioners Court in the Noble County Courthouse, Albion, Indiana, being the time, date and place set for a regular session of the Board of Commissioners of Noble County, Indiana.

#### Present were:

Gary Leatherman, President David J. (Dave) Dolezal, Vice President Dave Abbott, Member

Also present were:

Jacqueline L. Knafel, County Coordinator Dennis Graft, County Attorney and Mark Goodrich, Highway Superintendent Zack Smith, Highway Engineer

President Gary Leatherman brought the meeting to order at approximately 9:55AM.

## **HIGHWAY**

- Mark Goodrich, Highway Superintendent, is present discussing the underbody blades purchased earlier with carbide. Mark is having issues with the current blades and has discussed the issue with the company. He is looking into a double carbide blade as the current ones are not holding up as expected. Dave Abbott moved to approve the purchase of these blades. Dave Dolezal seconded the motion. Motion carried 3-0.
- Mark reported that a driver that had backed into a building in Noble Township now appears that the damage done to the shed in more than what was first thought. The accident was reported to the insurance company. This area is a dead end so to go the distance of the road required the driver to back out.
- Mark reported that the crews were out both Saturday and Sunday and also reported many issues with the trucks during this snow event.
- Utility permits were filed for NIPSCO, Frontier Communications and Ligonier Telephone Co.

Zack Smith, Highway Engineer, was present to discuss the following engineering business with the commissioners:

- Annual Bids Zack has reviewed all the bids and find them in order. There was one late bid but this was for slag and this is the only company that bid slag. With this information Dave Dolezal moved to accept all bids including the late bid for slag. Dave Abbott seconded the motion. Motion carried 3-0.
- Bridge 136 and Baseline Road Zack met with INDOT last week and got permission to start the process for these two projects Zack is drafting the RFPs.
- Community Crossing Grant Zack reported that the \$1,000,000 was finally received from the state on Friday of last week.
- Highway Garage Zack shared two e-mails from the engineering firm as well as the contractor concerning the new highway garage. Then engineering firm did not see that all of the billed by the contractor items were necessary and suggested that the amount of \$5,228.00 be paid rather than the requested \$9,113.00. Dave Dolezal moved to pay Mosiac \$5,228.00 based on the advice of the architect. Dave Abbott seconded the motion. Motion carried 3-0.
- Bridge 16 and 24 will be bid out in 2017
- Speed Studies on County Road 400 E and 225 E have been advertised and the public hearing is scheduled for January 9, 2017.

## **APPOINTMENT**

A letter had been received from Steve Hagen concerning the Noble County Redevelopment Commission. The commissioners have 3 appointment and those 3 wish to continue their

appointments to this board. Dave Abbott moved to appointment Scott Pounds, Rebecca Schroeder and Roger Diehm to serve on the Noble County Redevelopment Commission. Dave Dolezal seconded the motion. Motion carried 3-0.

#### VACATIONS

- Scott Ziegler, from a surveying firm, is representing Kevin Blaine in his request for a vacation of a street and two alleys in Kimmell. Mr. Blaine is wanting to eventually vacate the lots also and have one legal description. Dave Dolezal moved to approve this vacation with a second coming from Dave Abbott. Motion carried 3-0.
- Scott is also representing the Parks family in their vacation request for an alley at Knapp Lake. The goal here is to take 11 lots into 4 with this vacation. Dave Dolezal moved to approve the vacation of the alley at Knapp Lake. Dave Abbott seconded the motion. Motion carried 3-0.

#### GPA INSURANCE RUN OUT

Dave Abbott moved to approve a 12 month run out with GPA with the option of canceling the run out when it deems appropriate. Dave Dolezal seconded the motion. Motion carried 3-0.
