# BOARD OF COMMISSIONERS July 18, 2022

- I. CALL TO ORDER: The Parke County Board of Commissioners convened in a regular meeting at 4:00 p.m. on Monday, July 18<sup>th</sup>, 2022, having adjourned from a regular meeting on Monday, July 5<sup>th</sup>, 2022.
- II. ROLL CALL: Members present were Commissioner Jim Meece, President, Dan R. Collom, First Vice President; Bruce Hartman, Second Vice President; Laura Fischer, Auditor; Nicole Collings, First Deputy Auditor; and County Attorney Nick Sauter. Also, present were John Martin, Pam Sanders, Jessica Lancaster, Randy Norman, Cassie Wittenmyer and Cyndi Todd.
- **III.MINUTES:** Minutes for the regular meeting held on June 20<sup>th</sup>, 2022 were approved on a motion made by Dan R. Collom and seconded by Jim Meece. The motion carried unanimously. Minutes for the regular meeting held on July 5<sup>th</sup>, 2022 were approved on a motion made by Dan R. Collom and seconded by Bruce Hartman. The motion carried unanimously.
- **IV. PAYROLL:** County payroll in the amount of \$196,133.38 was approved for release on Friday, July 1<sup>st</sup>, 2022 on a motion made by Bruce Hartman and seconded by Dan R. Collom. The motion carried unanimously. Dan R. Collom made a motion acknowledging receipt of the Payroll Claims Accounts Payable Report in the amount of \$93,104.29. Bruce Hartman seconded the motion and it carried unanimously.

#### V. NEW BUSINESS:

- A hand typed check for Harris Computer Systems for \$629.71 was presented to the Board for an out of cycle check. Jim Meece made the motion to approve the out of cycle check. Dan R. Collom seconded the motion. Motion approved.
- Ordinance 2022-06 Phase 1 Plat of Nevins Estates Subdivision was before the Board for approval. This will create new plats with descriptions and addresses than they had previously. Bruce Hartman made the motion for same day same meeting approval of the ordinance. Dan R. Collom seconded the motion. Motion passed. Bruce Hartman made the motion for adoption of the Ordinance 2022-06 Phase 1 Plat of Nevins Estates Subdivision. Dan R. Collom seconded the motion. Motion passed unanimously.
- The SRI Agreement was presented for the Board's approval. The agreement is the same as previous years. Dan R. Collom made the motion to approve the SRI Agreement. Bruce Hartman seconded the motion. Motion passed.
- Don Pruner and Stan Rukes have been in discussion about cleaning up the Veterans' Memorial. Don Pruner would like to remove the two 4x4 post that hold flags. The Board approved the removal of the posts. Jim Meece would like the approval to power wash the stone. The Board approved Jim Meece to power wash the stone.
- Randy Cleaver and Chris O'Brien have been working on migrating the email systems to be more
  compliant with State requirements. They asked for the Matrix Integration Contract to be
  approved for a one-time fee of \$9,417.50 and monthly fee of \$510.00. Jim Meece made the
