

BOARD OF COMMISSIONERS
March 16th, 2015

- I. CALL TO ORDER:** The Parke County Board of Commissioners convened in a regular meeting at 4:00 p.m. on Monday, March 16th, 2015, having adjourned from a regular meeting on Monday, March 2nd, 2015.
- II. ROLL CALL:** Members present were Commissioners Jim Meece, President; Dan R. Collom, First Vice President; Bruce Hartman, Second Vice President; Janie Hardman, 1st Deputy Auditor; Rusty Ratcliff; Deputy Auditor and County Attorney John Asbury. Also present were Pam Sanders, Larry Bemis, Justin Cole, Randy Norman, Julie Johnson and Kristy Jerrell.
- III. MINUTES:** Minutes for the regular meeting held on Monday, March 2nd, 2015 were approved on a motion made by Bruce Hartman and seconded by Dan Collom. The motion carried unanimously.
- IV. PAYROLL:** County payroll in the amount of \$160,518.30, was approved for release on Monday, March 23rd, 2015 on a motion made by Bruce Hartman. Dan Collom seconded the motion and it carried unanimously. Bruce Hartman made a motion acknowledging receipt of the Payroll Claims Accounts Payable Report in the amount of \$129,515.13. Dan Collom seconded the motion and it carried unanimously. The Board acknowledged receipt of the February Monthly Financial Report.
- V. NEW BUSINESS:**

- Bruce Hartman made a motion to approve hand typed checks in the amount of \$537.64 payable to Alstaadt Office City for office supplies and in the amount of \$5,000.00 payable to ARSEE Engineering for bidding contingent upon Council approval of an additional appropriation. Dan Collom seconded the motion and it carried unanimously.
- Dan Collom made a motion to approve the Irish Mechanical Services, Inc. proposal to replace the chilled water coil in the York Air Handler with a four week coil lead time in the amount of \$20,620.00. Bruce Hartman seconded the motion and it carried unanimously.
- A claim acknowledgement from HCC Public Risk Claim Service, Inc. was presented for review.
- Sycamore Trails RC & D Woodland Owners Banquet notice was reviewed by the Board.
- The Board decided to take no action on the Commissioner letterhead.
- The Board denied requests from Wheels for Wishes and VA Home Loan Centers to place links on the County website.
- The Clerk's, Planning Commission and Treasurer's monthly reports were presented for review.

VI. OLD BUSINESS:

- Jim Luzar will prepare a letter explaining the merger of the Buildings & Grounds with the Fairgrounds Board. The Board will act on the Exercise of Option at the April 6th, 2015 meeting.
- Dan Collom made a motion to reverse the decision to close Raccoon Road for the ATV and motorcycle race May 1st – May 3rd, 2015 due to public concern. Bruce Hartman seconded the motion and it carried unanimously.

Parke County Sheriff, Justin Cole:

- The Jail count for today was fifty; forty-three County, five Department of Correction inmates and two out-of-county.
- Presented the February 2015 Report of Collections.

Parke County Highway, Randy Norman:

- Presented a claim for Bridge #72 for construction engineering in the amount of \$1,871.66.

- Reported Clark-Dietz will inspect the thirty-three bridges at a cost of \$210.61 per bridge due to the Federal requirement of bridge decks rated at four or below being inspected every twelve months. The County will have to enter into a supplemental contract with Clark-Dietz to cover the additional inspections.
- Reported crews have been working on a few roads that are impassable due to thawing.
