## BOARD OF COMMISSIONERS December 4th, 2017

- I. CALL TO ORDER: The Parke County Board of Commissioners convened in a regular meeting at 4:00 p.m. on Monday, December 4th, 2017, having adjourned from a regular meeting on Monday, November 20th, 2017.
- I. ROLL CALL: Members present were Commissioners Jim Meece, President; Dan R. Collom, First Vice President; Auditor Pam Adams; Laura Fischer, 1st Deputy Auditor; and County Attorney John Asbury. Bruce Hartman was absent. Also present were Pam Sanders, Larry Bemis, Karla Losin, Chris Marsolf, Kathy Collom, Tom Martin, Pam Sanders, Justin Cole, George Smith, Kim Shorter, Andy Thompson, Chester Crague and Randy Norman.
- **II. MINUTES:** Minutes for the regular meeting held on Monday, November 20th, 2017 were approved on a motion made by Dan Collom and seconded by Jim Meece. The motion carried unanimously.
- III. PAYROLL: County payroll in the amount of \$151,417.65 was approved for release on Monday, December 11th, 2017 on a motion made by Dan Collom. Jim Meece seconded the motion and it carried unanimously. Dan Collom made a motion acknowledging receipt of the Payroll Claims Accounts Payable Report in the amount of \$84,416.73. Jim Meece seconded the motion and it carried unanimously.
- **IV. CLAIMS:** After reviewing the Claims Docket, claims in the amount of \$525,355.84 were approved for release on December 4th, 2017 on a motion made by Jim Meece and seconded by Dan Collom. The motion carried unanimously.

## V. NEW BUSINESS:

- Dan Collom made a motion to approve hand type check for Sheriff's Department in amount of \$175.00, to Center for Education Union Hospital INC. Jim Meece seconded the motion and it carried unanimously.
- Dan Collom made a motion to approve hand type check for Dispatch Training for Emergency Management 911 in the amount of \$151.00. Jim Meece seconded the motion and it carried unanimously
- A letter from Larry Thompson was reviewed by the Commissioners, thanking the County for providing services through West Central Solid Waste District for collecting plastic bottle caps that he collected.
- The Board reviewed a notice of a public hearing from the Indiana Department of Transportation regarding the State Road 163 Bridge over the Wabash River at Clinton, Indiana. The hearing is scheduled for Wednesday, December 13th, 2017 at 6:00 p.m. and will be held at the Central Elementary School Gymnasium in Clinton, Indiana.
- Commissioners reviewed Indiana Department of Natural Resources letter of Historic Property report of Bridge US 41 over Roaring Creek, 0.40 (mile) south of State Road 47, in Penn Township.
- Jim Meece informed the Board that he would go to next County Council meeting to discuss the quote from Irish Mechanical Services, Inc. that was received regarding replacing the HVAC brass fittings which are beginning to fail, the quote is in the amount of \$24,420.00. Auditor Pam Adams advised the Board there are funds available that can be transferred within the Courthouse Custodian's 2017 budget which can be used towards the \$24,420.00 there will be approximately \$1,800.00 that will need to be funded by the Council.
- Grant money of \$13,240.00 was received from the Parke County Community Foundation for to
  install the WAVEPlus Security duress system in the Courthouse. Adams presented a
  quote/agreement from SecureTechWave Systems to for installation and implementation of the
  duress system. Dan Collom made a motion to approve the proposal, Jim Meece seconded the
  motion and it carried unanimously.
- The Board reviewed ARSEE Engineers, Inc. Meeting Report No. 15 and Field Report No. 23. Meece stated he will send a letter to Judge Swaim to advise him when the project will resume in

- 2018 which is projected to be around March 1st and should be completed by the end of June 2018 with weather permitting.
- Indiana Department of Environmental Management letter was reviewed by Board of Commissions regarding a confined feeding operation permit approval for TDM Land Company, LLC.
- Reviewed the 2018 Wabash River Heritage Corridor Commission (WRHCC) Board appointment materials. Meece stated the Town of Montezuma applied for a grant to be used on the Montezuma B&O Railroad pedestrian bridge project which was denied by the WRHCC, Meece stated he will look into the matter.
- Reviewed a Notice of Civil Tort filed by the Ken Nunn Law Office in Bloomington, Indiana on behalf of Henry C. Gordon, III. The information has been submitted to the County's insurance company.
- The Clerk's and Planning Commission monthly reports were reviewed by the Board.

#### VI. OLD BUSINESS:

- Reviewed a Civil Notice from Vigo Superior Court 6 in the matter of Jamie Plant v. CSX Transportation, Robert Farr, Richard Hookset al cause number 84D06-1710-CT-007568.
- Dan Collom made a motion to amend the Intermittent Leave or a Reduced Work Schedule Policy
  in the Employee Handbook. The new wording states: An employee who takes leave under this
  policy must provide a fitness for duty clearance from their health care provider that indicates the
  employee can return to work without any restrictions. Jim Meece seconded the motion and it
  carried unanimously.
- The Board reviewed an additional proposed amendment to employee hand book under the Introductory Period section: All new and rehired employees work on an introductory basis for first ninety (90) calendar days after their date of hire. **During this period, new employees will be required to attend a training session conducted by the County Auditor regarding the internal controls**. Upon satisfactory completion of the initial introductory period, **including the internal controls training**, employees enter the Regular Full time or Regular Part Time employment classification. Dan Collom made a motion to approve the amendment and Jim Meece second the motion. The motion carried unanimously.
- Pam Adams advised the Board that Parke County Incorporated (PCI) submitted invoices for Covered Bridge Festival related expenses in excess of the \$25,000.00 allotted by the County. Adams indicated her office contacted PCI Director Kelsey Canfield regarding the matter and Canfield said she will advise her Board at their meeting Wednesday, but she doesn't think there will be any issues. Adams requested to be allowed to process hand typed checks for the invoices, up to the \$25,000.00 allowed contingent upon the response from the PCI Board. Jim Meece made motion to allow the Auditor to process hand typed checks, not exceeding \$25,000.00 upon obtaining a response from Canfield after the PCI Board meeting. Dan Collom seconded the motion and it carried unanimously.

#### VII. DEPARTMENTAL REPORTS:

### Parke County Sheriff, Justin Cole:

- The Jail count for today was sixty-six; fifty County inmates, seven Department of Collection, one away, and eight out of county holds.
- Presented the Uniform Crime Report and Report of Collections for November 2017.
- Sheriff Cole reported they are in the process of interviewing for a new dispatcher and jail officer.

**George Smith, MJS Insurance,** presented a proposed liability and property renewal from Tokio / HCC Public Risk Insurance Company. The annual premium will be \$163,978.00 for 2018 with a \$2,500.00 deductible per occurrence. Jim Meece made motion to accept the renewal, Dan Collom seconded the motion and it carried unanimously.

#### **VIII. PUBLIC COMMENTS:**

Chester Crague inquired as to when roads can be repaired in Lyford and Bridgeton. Parke County Highway Supervisor, Randy Norman stated that there are plans to work on the roads in Lyford in 2018, but there are no immediate plans for road work in Bridgeton. Chris Marsolf reported he is working on updating the county website to become ADA compliant. Marsolf stated the County will not have to purchase any new software in order to meet the requirements. Meece asked Marsolf to find out if there could be a link added to the County website for the County's two libraries.
