# Leap Managed IT Quote Microsoft 360 licenses \$30,441.41

I was hoping to get a recommendation from the trails committee on who we should hire. BF&S, our airport engineering firm, has a trails division. They are the ones we paid \$4,950.00 to write the grant. I can't speak for the rest of the committee, but I would have been writing the grant I don't think we would have been approved, they did a nice job for us. I was impressed with what they did and obviously DNR was too. That's all I have this morning. Do we have any citizens that have comments this morning?
