JUDGE RIGGINS IS REQUESTING PERMISSION TO PLACE A PROBATION CHECK-IN KIOSK OVER AT THE JAIL. THIS WILL ALLOW LOW AND MEDIUM RISK PEOPLE THAT ARE ON PROBATION TO BE ABLE TO CHECK IN AND UPDATE THEIR INFORMATION AT THE KIOSK INSTEAD OF AT THE PROBATION OFFICE. CURRENTLY THE PROBATION OFFICE IS ONLY OPEN FROM 8-4 MONDAY THRU FRIDAY WHICH MAKE IS DIFFICULT FOR THE PEOPLE ON PROBATION TO GET TO THE OFFICE AND CHECK IN. THIS WILL MAKE IT NICER FOR THE ONES ON PROBATION BECAUSE THEY AREN'T HAVING TO REQUEST MORE TIME OFF OF WORK AND WE WANT THEM WORKING. JUDGE ADVISED HE RECEIVED A GRANT FOR THE FIRST YEAR IN THE AMOUNT OF \$15,000.00. CURRENTLY MARION COUNTY IS DOING THIS AND WORKING OUT OK. THIS WOULD ALSO ALLOW PEOPLE TO MAKE PAYMENTS ON THE KIOSK, AND TAKE THEIR BREATHALYZER TEST. THEY WILL HAVE TO SIGN IN WITH THEIR FINGERPRINT SO IT WILL HAVE TO BE THEM.
