SPEED LIMIT SET ON OLD STATE ROAD 252:

THE STATE HAS TURNED STATE ROAD 252 OVER TO THE COUNTY. THE ROAD WILL NOW BE NAMED OLD STATE ROAD 252 AND THE COUNTY NEEDS TO ADOPT AN ORDINANCE TO SET THE SPEED LIMITS FOR SHELBY COUNTY. JOHN DEPREZ PRESENTED THE COMMISSIONERS WITH ORDINANCE 2020-05 ADOPTING THE SAME SPEED LIMITS THAT WERE SET BY THE STATE:

45 MPH BETWEEN 300 FEET OF EAST OF 200 WEST TO 200 WEST

30 MPH BETWEEN 250 WEST TO 1,000 FEET WEST OF 300 WEST

40 MPH BETWEEN 1,000 FEET WEST OF 300 WEST TO 2,000 FEET WEST OF 300 WEST

45 MPH FLAT ROCK ROAD BETWEEN 200 WEST TO 1,175 FEET WEST OF 200 WEST

30 MPH BETWEEN 1,175 FEET WEST OF 200 WEST TO 250 WEST
