# AN ORDINANCE OF THE BOARD OF COMMISSIONERS OF SHELBY COUNTY, INDIANA, ADOPTING THE RECOMMENDATION OF THE SHELBY COUNTY ELECTION BOARD OF PROPOSED REDISTRICTING OF THE SHELBY COUNTY COUNCIL AND SHELBY COUNTY COMMISSIONERS DISTRICTS

WHEREAS, the Board of Commissioners of Shelby County, Indiana, are directed by I.C. 36-2-3-4 to divide the County into four (4) contiguous single member districts for the offices of the Shelby County Council; and

WHEREAS, the Board of Commissioners of Shelby County, Indiana, are directed by I.C. 36-2-2-4 to divide the County into three (3) districts that are composed of contiguous territory and reasonably compact for the offices of the Board of Commissioners; and

WHEREAS, the Board of Commissioners of Shelby County, Indiana, have solicited the assistance of the Shelby County Election Board by providing a recommended redistricting plan to the Board of Commissioners; and

WHEREAS, the Shelby County Election Board has submitted a proposed redistricting plan(by a 3-0 vote);

NOW THEREFORE, BE IT ORDAINED BY THE BOARD OF COMMISSIONERS OF SHELBY COUNTY, INDIANA, as follows:

The Board of Commissioners of Shelby County, Indiana, has found that pursuant to the requirements of I.C. 36-2-3-4 the four (4) districts of the Shelby County Council shall be redistricted

pursuant to the plan recommended by the Shelby County Election Board, which plan is attached hereto and made a part hereof as Attachment "A", Attachment "A-1" and Attachment "A-2".

The Board of Commissioners of Shelby County, Indiana, has found that pursuant to the requirement of I.C. 36-2-2-4 the three (3) districts of the Board of Commissioners shall be redistricted pursuant to the plan recommended by the Shelby County Election Board, which plan is attached hereto and made a part hereof as Attachment "B".

All ordinances and parts of ordinances in conflict with the specific amendments herein provided are repealed.
