ORDINANCE NO. 2007 -014

AN ORDINANCE to amend the County Thoroughfare and Traffic Code of the County of Shelby, Indiana, by amending Article 2, Chapter 4, Section 1 as it relates to County Road 1200 South, County Road 1100 South, County Road 600 South, County Road 500 South, County Road 350 South and Vandalia Road in Shelby County, Indiana and to repeal all ordinances and parts of ordinances in conflict therewith.

Be it ORDAINED by the Board of Commissioners of Shelby County, Indiana, as follows:

SECTION 1: Purpose. The purpose of this ordinance shall be to restrict all vehicular traffic traveling on County Road 1200 South from State Road 9 to Decatur County Line, County Road 1100 South from State Road 9 to Decatur County Line, County Road 600 South from State Road 9 to County Road 600 East, County Road 500 South from State Road 9 to County Road 600 East, County Road 350 South from State Road 9 to East Michigan Road and on Vandalia Road from State Road 9 to Decatur County Line to carrying a load limit of no more than ten (10) tons. Additionally, no thru commercial vehicles shall be permitted to operate on these roads.

SECTION 2: Amendment of County Code. Article 2, Chapter 4, Section 1 of the County Thoroughfares and Traffic Code, referred to as SCC 2-4-1, of Shelby County, Indiana, and the ordinances heretofore adopting said section of the code are hereby amended by adding to SCC 2-4-1 a designation restricting all vehicular traffic traveling on County Road 1200 South from State Road 9 to Decatur County Line, County Road 1100 South from State Road 9 to Decatur County Line,

County Road 600 South from State Road 9 to County Road 600 East, County Road 500 South from State Road 9 to County Road 600 East, County Road 350 South from State Road 9 to East Michigan Road and on Vandalia Road from State Road 9 to Decatur County Line to carrying a load limit of no more than ten (10) tons. This Ordinance is not applicable to individuals operating vehicles for local purposes.

<u>SECTION 3:</u> There shall be added the following marked designations to SCC 2-4-1:

ROAD	PORTION AFFECTED	LOAD LIMIT
1200 South, 1100 South, Vandalia Road	S.R. 9 to Decatur County Line	10 tons
600 South, 500 South	S.R. 9 to 600 East	10 tons
350 South	S.R. 9 to East Michigan Road	10 tons

SECTION 4: Effective Date. This ordinance shall be in full force and effect from and after its adoption by the Board of Commissioners of Shelby County, Indiana, publication as required by law, and upon the posting of the necessary signs indicating a weight limit on the above specified county roads by the County Highway Superintendent at which time it shall be enforceable by all public law enforcement officers in the same manner as the enforcement of all other provisions of Article 2 of the Shelby County Code.

<u>SECTION 5: Violations.</u> Article 2, Chapter 4, Section 1 of the Thoroughfare and Traffic Code of Shelby County, Indiana, shall be applicable and apply to the enforcement of this ordinance.

<u>SECTION 6: Repealable provisions.</u> All ordinances and parts of
