

ORDINANCE NO. 2007- 0 6

AN ORDINANCE OF THE SHELBY COUNTY COUNCIL,  
SHELBY COUNTY, INDIANA AUTHORIZING THE  
PAYMENT OF A FLAT RATE FOR OFFICERS  
PARTICIPATING IN A SPECIAL DETAIL ASSIGNMENT

WHEREAS, the Shelby County Council now finds that the necessity exists to authorize the Shelby County Sheriff to establish a flat rate of compensation for officers who voluntarily participate in "Operation Pullover" and "Impaired Driver Project" and those officers who are called out as part of the "Fatal Crash Team"; and

WHEREAS, the Shelby County Sheriff receives grants to provide funding for "Operation Pullover", "Impaired Driver Project", and "Fatal Crash Team" and it is necessary for the Shelby County Sheriff to provide an accounting of the use of said grants in advance of the expenditures which requires the scheduling of officers to perform those duties on a voluntary basis and not as part of their regular employment and those officers who are called out to participate in the "Fatal Crash Team"; and

WHEREAS, for the purposes of scheduling and meeting the accounting requirements, it is in the best interests of the Shelby County Sheriff to establish a flat rate of compensation for those officers who volunteer to participate in special detail assignment ("Operation Pullover" and "Impaired Driver Project"), which is permissible pursuant to the Fair Labor Standards Act, and officers who are called out as part of the "Fatal Crash Team".

NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE COUNTY OF SHELBY, as follows:


The Shelby County Sheriff is hereby authorized to establish a flat rate of compensation for officers who voluntarily participate in "Operation Pullover" and "Impaired Driver Project" and officers who are called out as part of the "Fatal Crash Team", for the purposes of meeting scheduling and accounting requirements; and


The Shelby County Sheriff is hereby authorized to establish a flat rate of compensation for officers who voluntarily participate in "Operation Pullover" and "Impaired Driver Project" and officers who are called out as part of the "Fatal Crash Team", with said rate of compensation to be \$25.00 per hour plus \$1.92 for fringe benefits. The compensation provided for herein shall be paid solely from grants received from the Shelby County Sheriff to provide for the funding of "Operation Pullover" and "Impaired Driver Project" and officers who are called out as part of the "Fatal Crash Team".


