ORDINANCE NO. 2008 - 02

AN ORDINANCE to amend the County Thoroughfare and Traffic Code of the County of Shelby, Indiana, by amending Article 2, Chapter 4, Section 2 as it relates Bridge No. 8 located at County Road 600 West and County Road 1180 North and Bridge No. 13 located at County Road 875 West and County Road 690 North, in Shelby County, Indiana and to repeal all ordinances and parts of ordinances in conflict therewith.

Be it ORDAINED by the Board of Commissioners of Shelby County, Indiana, as follows:

SECTION 1: Purpose. The purpose of this ordinance shall be to prohibit any person to operate any vehicle with a gross weight/load limit in excess of ten (10) tons upon or across Bridge No. 8 located at County Road 600 West and County Road 1180. Additionally, no person shall operate any vehicle with a gross weight/load limit in excess of six (6) tons upon or across Bridge No. 13 located at County Road 875 West and County Road 690 North.

SECTION 2: Amendment of County Code. Article 2, Chapter 4, Section 2 of the County Thoroughfares and Traffic Code, referred to as SCC 2-4-2, of Shelby County, Indiana, and the ordinances heretofore adopting said section of the code are hereby amended by adding or amending SCC 2-4-2 by listing the gross weight/load limit for any vehicle traveling upon or across Bridge No. 8 and Bridge No. 13 as specified in Section 1 above.

SECTION 3: There shall be added the following marked designations to SCC 2-4-2:

BRIDGE LOCATION	BRIDGE NUMBER	LOAD LIMIT
600 West and 1180 North	8	10 tons
875 West and 690 North	13	6 tons

<u>SECTION 4:</u> <u>Effective Date.</u> This ordinance shall be in full force and effect from and after its adoption by the Board of Commissioners of

Shelby County, Indiana, publication as required by law, and upon the posting of the necessary signs indicating a weight limit on the above specified county bridges by the County Highway Superintendent at which time it shall be enforceable by all public law enforcement officers in the same manner as the enforcement of all other provisions of Article 2 of the Shelby County Code.

<u>SECTION 5: Violations.</u> Article 2, Chapter 4, Section 3 of the Thoroughfare and Traffic Code of Shelby County, Indiana, shall be applicable and apply to the enforcement of this ordinance.

<u>SECTION 6:</u> Repealable provisions. All ordinances and parts of ordinances in conflict with the specific amendments herein provided are repealed.
