ZONING ORDINANCE AMENDMENT

THIS IS AN ORDINANCE for the purpose of amending and changing the zoning ordinance of the County of Shelby as it relates to a certain tract of property known as 4095 N 775 E and 3950 N 775 E, Manilla, Indiana. Specifically amending the Shelby County, Indiana Zoning Ordinance adopted by the Board of Commissioners of Shelby County, Indiana on September 18, 2008, which became effective on October 18, 2008, including and incorporating therein Township Zoning Maps dated September 18, 2008 as amended, showing the boundary lines of certain Zoning Districts thereon.

BE IT ORDAINED by the Board of Commissioners of Shelby County Indiana, as follows:

Section 1: Purpose. The purpose of this Ordinance shall be to amend the Zoning Map of Union Township of the Shelby County Code and the zoning ordinances thereunder as it relates to the real estate specifically described in Section 2 of this Ordinance to change the designation of said real estate from being zoned A1 — Conservation Agricultural to a designation A2-Agricultural (approximately 32.7 acres).

Section 2: Amendment. Shelby County, Indiana Zoning Ordinance adopted by the Board of Commissioners of Shelby County, Indiana on September 18, 2008, which became effective on October 18, 2008, including and incorporating therein Township Zoning Maps dated September 18, 2008, as amended, showing the boundary lines of certain Zoning Districts thereon, are hereby amended by adding the following subsection:

Land rezoned from "A1," Conservation Agricultural, to "A2", Agricultural

The following parcel of land and real estate located in Union Township, Shelby County, Indiana and particularly described herein being formerly zoned and shown on the Union Township Zoning District Map and lying in an "A1" Conservation Agricultural district is hereby rezoned to "A2" Agricultural:

Section 3: Effective Date. This ordinance shall be in full force and effect from and after its adoption by the Board of Commissioners of Shelby County, Indiana.

Section 4: Repealable Provisions. All ordinances and parts of ordinances in conflict with the specific amendment herein are hereby repealed.

Commencing at the Northeast corner of the said quarter-quarter section; thence South 00 degrees 45 minutes 10 seconds East (Bearings based on NAD 83, Indiana East, State plane Coordinates), along the East line of the said quarter-quarter section a distance of 421.00 feet to the East side of a corner post; thence North 80 degrees 07 minutes 26 seconds West, along the South boundary line of a 4.452 acre tract a distance of 382.71 feet to the point of beginning of the centerline of a 50 foot wide easement herein described; thence South 32 degrees 51 minutes 17 seconds West, along the centerline of the said easement a distance of 165.98 feet to a point on the Northerly boundary line of a 11.694 acre tract, said point also being the point of ending of the said easement. Said easement is to be extended or shortened to intersect the said boundary lines.
