

ORDINANCE NO. 2022 - 14

ZONING ORDINANCE AMENDMENT

THIS IS AN ORDINANCE for the purpose of amending and changing the zoning ordinance of the County of Shelby as it relates to a certain tract of property located on the south side of CR 1100 N, 0.4-mile east of CR 200 W, Van Buren Township. Specifically amending the Shelby County, Indiana Zoning Ordinance adopted by the Board of Commissioners of Shelby County, Indiana on September 18, 2008, which became effective on October 18, 2008, including and incorporating therein Township Zoning Maps dated September 18, 2008 as amended, showing the boundary lines of certain Zoning Districts thereon.

BE IT ORDAINED by the Board of Commissioners of Shelby County Indiana, as follows:

Section 1: Purpose. The purpose of this Ordinance shall be to amend the Zoning Map of Van Buren Township of the Shelby County Code and the zoning ordinances thereunder as it relates to the real estate specifically described in Section 2 of this Ordinance to change the designation of said real estate from being zoned A1 (Conservation Agricultural) to RE (Residential Estate) (10 acres). A petition was filed by Brandon Schuneman on April 5, 2022 under Case No. RZ 22-09, to amend the zoning map of Shelby County, Indiana to change the zoning of said real estate.

Section 2: Amendment. Shelby County, Indiana Zoning Ordinance adopted by the Board of Commissioners of Shelby County, Indiana on September 18, 2008, which became effective on October 18, 2008, including and incorporating therein Township Zoning Maps dated September 18, 2008, as amended, showing the boundary lines of certain Zoning Districts thereon, are hereby amended by adding the following sub-section:


Land rezoned from "A1," Conservation Agricultural, to "RE" Residential Estate:

The parcel of land and real estate located in Van Buren Township, Shelby County, Indiana and particularly described by the attached legal description Exhibit "A" and shown on the attached map, Exhibit "B", being formerly zoned and shown on the Van Buren Township Zoning District Map as lying in an "A1" Conservation Agricultural District is hereby rezoned to "RE" Residential Estate.

Section 3: Effective Date. This ordinance shall be in full force and effect from and after its adoption by the Board of Commissioners of Shelby County, Indiana.

Section 4: Repealable Provisions. All ordinances and parts of ordinances in conflict with the specific amendment herein are hereby repealed.

ADOPTED this 16th day of May, 2022 by a vote of 3 ayes and 0 nays of members of the Board of Commissioners of Shelby County, Indiana.



EXHIBIT A

LEGAL DESCRIPTION OF LOT 1

Part of the north half of the northwest quarter of Section Twelve (12), Township Fourteen (14) North, Range Six (6) East of Van Buren Township, Shelby County, Indiana, being part of survey Job #14N6E12-22-016 by Scott T. Sumerford, RLS#29800017, certified April 26, 2022 and being more particularly described as follows:

Commencing at the northwest corner of the northwest quarter of said section 12-14-6, said point marked by a rebar; thence along the north line of said northwest quarter, North $87^{\circ}46'38''$ East (basis of bearings being Indiana State Plane East Zone) 1980.24 feet to a magnall and washer stamped "S. Sumerford 9800017" at the point of beginning of the herein described tract;

Thence continuing North $87^{\circ}46'38''$ East 606.00 feet to a magnall and washer stamped "S. Sumerford 9800017", said point being South $87^{\circ}46'38''$ West 146.00 feet from the northeast corner of said northwest quarter; thence South $00^{\circ}00'08''$ East 730.03 feet to a capped rebar stamped "S. Sumerford 29800017"; thence parallel with the north line of said quarter, South $87^{\circ}46'38''$ West 588.30 feet to a capped rebar stamped "S. Sumerford 29800017"; thence North $01^{\circ}23'29''$ West 729.55 feet to the point of beginning, containing 10.000 acres.

Subject to all easements, restrictions and right-of-ways of record.
