RESOLUTION QUALIFYING CERTAIN REAL PROPERTY AND PERSONAL PROPERTY FOR TAX ABATEMENT

WHEREAS, the Shelby County Council has received a written Application filed on behalf of Textron Automotive Company for real property and personal tax abatement, pursuant to Ind. Code 6-1.1-12.1-1 et. seq., and

WHEREAS, said Application has been reviewed by the Shelby County Council at a duly held public meeting of said Council on the 10th day of April, 2001.

THEREFORE, be it resolved by the Shelby County Council as follows:

- The Shelby County Council has reviewed the Application of Textron Automotive
 Company and determined that it should be granted.
- 2. The Shelby County Council has determined that the estimated cost of the improvements will be \$2,403,778.00, and the estimated number of individuals employed after the completion of construction will be an additional 55 persons. Further, the Shelby County Council has determined that the annual salaries and benefits for the new employees will be approximately \$1,650,000.00.
- 3. The Shelby County Council has determined that the benefits to the community are great, and more than sufficient to justify the deductions sought by the Textron Automotive Company Application.
- 4. Accordingly, the Shelby County Council has determined that Textron Automotive Company is entitled to a reduction from the assessed value of its real property improvements for a period of ten (10) years, pursuant to Ind. Code 6-1.1-12.1-4 and the following schedule:

5. It is further resolved by the Shelby County Council that Textron Automotive Company shall be entitled to a reduction from the assessed value of the equipment set forth in its application for a period of ten (10) years, pursuant to Ind. Code 6-1.1-12.1-4.5 as follows:

6. Upon the adoption of this resolution, the Shelby County Council shall serve a copy of this resolution, including the legal description of the aforementioned real estate, to the Shelby County Assessor and/or such other Shelby County governmental officials, as shall be necessary to make Textron Automotive Company, its successors and assigns, eligible to file for the deductions as set forth herein.
