Director's Update:

- Supervision numbers were average the last quarter of 2024, ending October with 91; November with 83; and December with 81 our average is 84.
- Our local health department provided Court Services with an AED for our field vehicles and provided four Stop the Bleed kits and CPR valves and masks for our offices and field vehicles, all to support our emergency preparedness efforts.
- Court Services is in the process of updating our Adult Day Reporting Program and CTP programs.
- DOC grant applications are being accepted for 2026 and Court Services in preparing their application.

Juvenile Grant Transfer Amendment Request Form was presented in order to shift our focus towards juvenile prevention programming and to use PI/User Fee funds to make purchases for food, office supplies, cleaning supplies, miscellaneous supplies, miscellaneous services, and office equipment instead of paying through our grant. We will use grant funds to support prevention and assistance services such as after-school programming, prosocial extracurricular activities, or educational opportunities.
