- Josh updated everyone on our current supervision numbers. There are currently 36 participants on Home Detention. He talked about the recent cuts he has made to our budget. He has eliminated a full-time Field Officer position, and currently we are not filling an open Case Manager position. Additionally, he has cut \$6,000.00 in our Travel- Training fund and \$25,000.00 from our Equipment Leasing fund in our Adult PI, and \$3,500.00 in our Juvenile PI.
- Judge Apsley asked what Community Corrections plan is regarding meeting with County
  Council going forward about our financials for 2024. Josh plans on updating Leigh
  Langkable during the next County Council meeting regarding when Community Corrections
  will be requesting \$100,000 in racino funds that have been earmarked to help with our
  Project Income budget.
- Alison Everhart gave an update on Court Services and how herself and Josh met with the judges last week, then Ali will go before the commissioners in the near future. Judge Apsley asked if the commissioners have approved Court Services yet. Alison said that it hasn't been officially approved yet. Judge Apsley suggested getting the merger to Court Services approved by the commissioners sooner rather than later, and to get it approved prior to January 1, 2024. Alison will get the approval on the next commissioners meeting agenda.
