Shelby County selected to hold pipeline exercise, more information to come. Group was encouraged to RSVP when dates selected.

Tyner asked group to consider replacing sensors in 10 gas detector the LEPC purchased for Fire Departments several years ago. Tyner noted a cost of \$432 per detector. Weidner motioned to spend up to \$432 per unit, Sellers second.

Cain advised that he has the capability to calibrate the meters in house at Knauf.

Sellers thanked American Water, Shelbyville Fire, Moral Township Vol. Fire, Fairland Vol. Fire, and Shelby County EMA for assistance during water outage at MHP.

Debaun noted 4 of 70 have filed Tier II reports, and the county map showed the updated reports.

Debaun received a letter from Sam George of Sysco Group. They would like to be considered for their services.

Beyer is working to split LEPC plan into smaller files to assist with uploading plan to the state.
