New Business:

RZ 24-02 – STEPHENS REZONING: Rezoning of 5-acres from the A1 (Conservation Agricultural) District to the A2 (Agricultural) District to allow for a one-lot Simple Subdivision. Located on the north side of CR 300 S, 1000-feet west of CR 600 E, Liberty Township.

Desiree Calderella read the petition into the record and stated that Staff recommends approval.

Simple Subdivision of 5-acres from a 75.01-acre parent tract and waiver of Simple Subdivision prerequisites to allow for Simple Subdivision of property zoned A2. Located on the north side of CR 300 S, 1000-feet west of CR 600 E, Liberty Township.
