# American Legal / Knowink Invoices

# **Congressional School Fund**

Bunner was requested to research the Congressional School Fund and provide an explanation as to this fund. The Congressional School Fund was derived from the sale of the 16<sup>th</sup> section of land in each congressional township, or land equivalent there to, granted or reserved to the inhabitants of each township by an Act of Congress passed on 4/19/1816. The principal of the fund must be perpetually held in trust. The amounts held in trust by the respective townships have not changed since 1932. This is reported twice a year. The Treasurer prepares it, the Auditor sends it, and the Commissioners approve it.
