

GENERAL ORDINANCE NO. 2002 VI

GENERAL ORDINANCE FOR CLOSING UNIMPROVED COUNTY ROADWAYS

BE IT ORDAINED by the Board of Commissioners of Wabash County, Indiana, under authority of Indiana statutes and after thorough and complete investigation, examination, advertised notice, joining owners notice and public hearing, that the following unimproved/unmaintained county roadways shall be closed and not open to any manner or method of transportation:

Chester Township:

1. CR 600 E, starting at SR 16 to CR 700 N
2. CR 400 E starting at CR 1400 N to CR 700 N

Lagro Township:

1. CR 450 E starting at new U. S. 24 to CR 200 N, about 3/8 mile;
2. CR 750E from north of Division Road to CR 100 N (also known as Belden Rd.)
3. CR 175 E starting approximately 2700 ft. south of CR 200 N, then south approximately 4200 ft (to where road terminates)
4. CR 600 E starting from CR 500 N (Silver Creek Church), then north to St. Rd 16.
5. CR 200 N starting from CR 500 E to CR 600 E

Liberty Township:

1. CR 200 E starting 260 ft south of St. Rd. 124, then south for approximately 2940 ft.
2. CR 100 E starting at CR 950 S, then south into U. S. Corps of Engineers' property (about 1/2 mile) then in an easterly direction in Corps of Engineers' property, ending at CR 200 E, totaling about 1 1/2 miles
3. CR 850 S starting at Old St. Rd. 15 and continuing in an easterly direction for about 4800 ft., ending at CR 390 E
4. CR 1000 S starting at CR 390 E, continuing in an easterly direction for about 4650 ft. to America Rd.

Noble Township:

1. Water Works Road from CR 200 E, west for 6/10 of a mile
2. CR 350 S starting at CR 100 E to CR 200 E


PawPaw Township:

1. CR 750 N starting at Alger Cemetery, 2710 Ft. east of CR 200 W, east then south to CR 700 N
2. CR 100 W between CR 500 N and St. Rd. 16, being about 5400 feet.
3. CR 100 W between CR 300 N and CR 400 N
4. CR 700 N starting 2640 ft. west of CR 700 W to CR 800 W (Wabash/Miami Co. line), being about 1/2 mile

The effect of this Ordinance shall be to close all methods of transportation on the above-referenced County Roads.

PASSED by the Board of Commissioners of Wabash County, Indiana, this 12<sup>th</sup> day of November, 2002.


