## Wabash County Ordinance No. <u>98-6</u>

An Ordinance Increasing The Uniform County Inkeeper's Tax from 3% to the 5% of the Gross Retail Income Received from Lodging in Wabash County

WHEREAS, the General Assembly of the State of Indiana has enacted the Uniform County Innkeeper's Tax, Indiana Code I.C. 6-9-18 which permits Wabash County ("County") to levy a tax at the rate of five percent (5%) of the gross retail income derived from the renting or furnishing, for periods of less than thirty (30) days, any room or rooms, lodgings, or accommodations in any hotel, motel, boat motel, inn, college or university memorial union. college or university residence hall or dormitory, or tourist cabin in the County ("Tax"); and

WHEREAS, the Wabash County Council previously adopted an ordinance imposing the Uniform County Inkeeper's Tax at the rate of three percent (3%) of the gross retail income received from lodging in Wabash County instead of the maximum five percent (5%) permitted by Indiana Code I.C. 6-9-18-3; and

WHEREAS, the County Council ("Council") desires to increase the Tax on transactions that occurr after January 1, 1999 to five percent (5%); therefore,

BE IT ENACTED BY THE COUNCIL THAT: Section 1. The Wabash County Council does hereby increase the Uniform County Innkeeper's Tax from three percent (3%) of the gross retail income derived from lodging income only to five percent (5%) of the gross retail income derived from lodging income only.

Section 2. The Council will send a certified copy of this Ordinance to the Commissioner of the Department of State Revenue immediately upon adoption of this ordinance.

Section 3. This Ordinance shall be effective January 1, 1999.
