**GENERAL ORDINANCE NO. 85-10, 2010**

**AN ORDINANCE VACATING AN ALLEY IN LIBERTY MILLS, INDIANA**

WHEREAS, there was filed a petition to vacate an alley in Liberty Mills, Indiana.

WHEREAS, on December 20, 2010, as required by law and following proper mailing and publication of notice, a public hearing was held on said petition.

WHEREAS, on December 20, 2010, it was deemed by the Board of Commissioners of Wabash County, Indiana, to be in the best interests of the County to vacate the alley as requested.

IT IS NOW ORDAINED THAT THE FOLLOWING DESCRIBED ALLEY IS NOW VACATED:

A 16.5 foot wide alley and the un-vacated portion of Railroad Street beginning at the northwest corner of lot 33 of Comstocks 2<sup>nd</sup> Addition, then north along the east right of way of 2<sup>nd</sup> Street to the south line of a 3.07 acre parcel, 85-03-22-302-098.000-001, then in a northeasterly direction along the south line of the 3.07 acre parcel to the west right of way of 3<sup>rd</sup> Street, then south parallel with the 3<sup>rd</sup> Street right-of-way to the northeast corner of lot #27 of Comstocks 2<sup>nd</sup> Addition in a west and southwesterly direction to the northwest corner of lot #33.

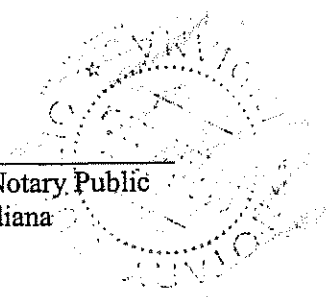
