GENERAL ORDINANCE NO. 5-1991

WABASH COUNTY ORDINANCE RE-DISTRICTING COUNTY COUNCIL AREA OF DISTRICT REPRESENTATION AND ELECTION

WHEREAS, the County of Wabash, State of Indiana, is divided for governmental and election purposes into seven (7) council districts, three (3) of which are councilors at large representing and elected by all county voters; and

WHEREAS, four (4) council districts hereinafter known as counsel districts #1, #2, #3 and #4 are elected by and represent residents and voters in specified and designated county areas, and

WHEREAS, it is proper and necessary for these county council districts to be re-designated and re-apportioned; and

WHEREAS, it is in the best interest of representation and fairness for the areas to be as equal in population as possible; and

WHEREAS, it is proper and correct for such districts to be laid out in such a fashion that they do not divide voter precincts.

NOW, THEREFORE, it is hereby ordained by the Commissioners of Wabash County that the council districts be re-established and re-districted as set out hereinafter, and all prior ordinances or resolutions of said county enacted prior hereto are revoked and abolished as of the effective date of this ordinance.

County Council District 1 shall include the following:

Chester Township voter precinct #1 Chester Township voter precinct #2 Lagro Township voter precinct #3 Chester Township voter precinct #3, #4, #5 & #6

Paw Paw Township
Noble Township voter precinct #5
Noble Township voter precinct #8




