One (1) freeholder of Wabash County, IN filed a petition to vacate a portion of Ruth Street  
Ruth Street in Speichers Third Addition in the Town of Urbana, Wabash County, IN.

On April 21, 2014 as required by law and following proper notification to abutting  
property owners and publication of notice, a public hearing was held on said petition.

The Board of Commissioners of Wabash County, Indiana determined that the request to  
vacate a portion of Ruth Street, in Speichers Third Addition of Urbana, Wabash County, IN

Legal Description


A portion of Ruth Street within the original plat of Speichers Third Addition to the Town of  
Urbana, Wabash Co., IN as recorded in plat book #3, page 216 and 217  
Beginning at the Southeast corner lot line of Lot 43, and continuing south to the north  
lot line of Outlot 1; then continuing west along said lot line to the northwest corner  
of Outlot 1; then north along railroad right of way to southwest corner of lot line 43;  
then east along lot line of Lot 43 to the point of beginning.



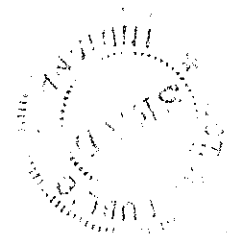
