GENERAL ORDINANCE NO. 2014-85-6

**AN ORDINANCE GRANTING THE RECORDER'S REQUEST TO USE
MONIES FROM THE RECORDER'S RECORDS PERPETUATION FUND
TO SUPPLEMENT THE RECORDER'S 2015 BUDGET**

By the affidavit contemplated by I.C. 36-2-7-10.2(b), the County Recorder has requested that the sum of \$52,418.00 of the Recorder's Perpetuation Fund be used to supplement payment of the expenses of her office for the 2015 calendar year.

Pursuant to I.C. 36-2-7-10.2(c), upon receiving the Recorder's affidavit, the County Council may adopt an ordinance approving the Recorder's request.


The Recorder's affidavit is in proper form and content and the County Council wishes to grant the Recorder's request.

NOW, THEREFORE, IT IS ORDAINED AS FOLLOWS:

1. The request of the County Recorder asking that the sum of \$52,418.00 of the Recorder's Perpetuation Fund be used to supplement payment of the expenses of her office for the 2015 calendar year is granted.
