

GENERAL ORDINANCE NUMBER 1990-1AN ORDINANCE FOR VACATING AND CLOSING
PREVIOUSLY PLATTED COUNTY HIGHWAYS

Be it ordained by the Board of Commissioners of Wabash County, Indiana, under authority of Indiana code 8-20-1-1 et. seq., and all other acts amendatory thereof to the General Assembly of the State of Indiana;

Whereas, the Board of Commissioners of Wabash County, Indiana, have reviewed and considered the utility and public purpose of certain designated County Highways that are unimproved and/or have not been maintained for a period in excess of twenty (20) years. After public notice by advertising with hearing thereon December 18, 1989, and no objections being raised do hereby and hereinafter vacate and close the following roads and the appropriate location and distance of each road as indicated on the J.M. Crumrine map of January 1, 1910:

- 100 W....From 500 N to 600 N
- 1300 N....From Bonestead Road West to West County Line (800 W)
- 750 W....From approximately 1/2 mile South of 1400 N to S.R. 114 (1200 N)
- 1460 N....From 400 W to 300 W
- 450 W....From 1300 N to 1400 N
- 400 E....From 1400 N, North 1/2 mile to approximately 1450 N
- 750 N....From 1/2 mile East of 200 W proceeding East and South to 700 N
- 650 W....From 1/2 mile North of 1000 N to 1050 N
- 900 N....From 1/2 mile East of 700 W to 600 W
- 850 N....From 600 W to 500 W
- 900 N....From 1/2 mile East of 400 W proceeding East and North to 1/2
mile South of 1000 N
- 950 N....From 200 W proceeding West to Troyer Road
- 600 E....From 500 N to 700 N
- 100 N....From 1/2 mile West of S.R. 13 proceeding West to 100 W
- 100 W....From 300 N to 400 N
- 410 S....From Bailey Road to Old 15
- 175 E....From 1/2 mile South of 200 N to 1/4 mile North of U.S. 24
- 150 N....From 1/2 mile East of 400 E proceeding North to 200 N
- 200 N....From 500 E to 600 E
- 750 E....From 1/3 mile North of Division Road to 100 N or Beldon Road
- 350 S....From 1/2 mile East of Old S.R. 15 to 200 E
- 200 E....From 1/2 mile North of 700 S to 600 S (S.R. 124)
- 1000 S....From 390 E proceeding East to America Road
- 850 S....From 390 E proceeding West to Old S.R. 15

100 E....From 950 S proceeding South and East to 1000 S

100 W....From approximately 1 and 1/10 mile North of 400 S to Old S.R. 15
or Choketown

450 W....From 400 S North to Mill Creek Pike

700 N....From 1/2 mile West of 700 W to 800 W

Waterworks Road....From 200 E West approximately 6/10 mile

Edsall Street.....From Wabash City Limit proceeding West to end

This list also includes several portions of roads which were abandoned due to the construction of the Salamonie and Mississinewa Reservoirs and are now part of Federal property. Some of these roads may have been officially closed by previous Commissioners' actions.
