

GENERAL ORDINANCE NUMBER 88-7

AN ORDINANCE FOR PARTIAL VACATION OF PLATTED COUNTY ROADWAY

Be it ordained by the Board of Commissioners of Wabash County, Indiana, under authority of Indiana code 8-20-1-1 et. seq., and all other acts amendatory thereof to the General Assembly of the State of Indiana;


Whereas, the Board of Commissioners of Wabash County, Indiana, has determined that it would be in the best interest of public safety and welfare and for the best interest of all residents of Wabash County that the following described portion of platted but undeveloped roadway be vacated;


1. Part of Reserve number 19, T 27 N, R 6 E, Wabash County, Indiana. Being at a point 1780 ft. north of an iron stake marking the southwest corner of said Reserve number 19 said point being the northwest corner of County road 100 W (Union Chapel Road) and also being 160 ft. south of the northeast corner of the F.O.P. Lodge in reserve number 18; Thence, north 938.7 ft. to the north line of real estate owned and presently in the name of Robert E. Kirby and Barbara Ellen Kirby and the south line of real estate presently in the name of Paul McKnight and Roberta Sue McKnight.


Now therefore, from and after the completion of all necessary and appropriate processes of notice and hearing that the following portion of platted but undeveloped County Road 100 W. as designated hereinafter shall be and is vacated, no longer to be part of the County Highway System, to-wit:

1. Part of Reserve number 19, T 27 N, R 6 E, Wabash County, Indiana. Being at a point 1780 ft. north of an iron stake marking the southwest corner of said Reserve number 19 said point being the northwest corner of County road 100 W. (Union Chapel Road) and also being 160 fo. south of the northeast corner of the F.O.P. Lodge in Reserve number 18; Thence, north 938.7 ft. to the north line of real estate owned and presently in name of Robert E. Kirby and Barbara Ellen Kirby and the south of real estate presently in the name of Paul McKnight and Roberta Sue McKnight.


