## GENERAL ORDINANCE NO. AN ORDINANCE CREATING STOP INTERSECTIONS AND DIRECTING PLACEMENT OF STOP SIGNS

BE IT ORDAINED by the Board of Commissioners of Wabash County, Indiana, under authority of Chapter 112, Acts of 1919, Chapter 48, Acts of 1939, Chapter 48, Acts of 1947, and Chapter 338, Acts of 1947, and all Acts amendatory thereto, General Assembly of the State of Indiana;

WHEREAS, the Board of Commissioners of Wabash County,
Indiana, has determined that certain traffic control devices need
to be placed at the Intersection of County Road #600 East, said
County Road #600 East being commonly known as the Waggoner Road
at its intersection with County Road #1000 South, which said
road #1000 South is commonly known as the Rennaker Road, and,

WHEREAS, the Board of Commissioners of Wabash County, Indiana has determined that certain traffic control devices should be placed on the Bailey-Gertner Road at its intersection with County Road #500 South, said County Road #500 South being commonly known as the Wolf Road, and,

WHEREAS, the Board of Commissioners of Wabash County, Indiana has determined that the Stop Sign on County Road #300 East, commonly known as the Lagro-Servia Road at its intersection with County Road #800 North should be removed,

NOW THEREFORE, from and after the erection of appropriate signs, traffic moving in a southerly direction on County Road #600 East shall be required to stop at the intersection of said County Road #600 East with County Road #1000 South and said traffic shall proceed only at such time as it is safe to do so.

Further, that traffic moving on the Bailey-Gertner Road Shall be required to stop at the intersection of the said Bailey-Gertner Road with the intersection of County Road #500 South, said County Road #500 South being commonly known as the Wolf Road, and said traffic after said stop shall proceed only at such time as it is safe to do so, and,

Further, that the stop sign which now exists on County Road #300 East, said County Road #300 East being commonly known as the Lagro-Servia Road at its intersection with County Road #800 North shall be removed and said County Road #300 East shall then become a preferential highway.

This Ordinance shall be in full force and effect from and after the erection of stop signs at all corners at said locations and the removal of the stop sign at County Road #300 East with its intersection with County Road #800 North.

If a part of this Ordinance is invalid, all valid parts that are severable from the invalid parts shall remain in full force and effect.
