

GENERAL ORDINANCE NO. 10

AN ORDINANCE CREATING SPEED
ZONES AND DIRECTING PLACEMENT
OF SPEED ZONE SIGNS

BE IT ORDAINED by the Board of County Commissioners of Wabash County, Indiana, under authority of Chapter 112, Acts of 1919, Chapter 48, Acts of 1939, Chapter 48, Acts of 1947, and Chapter 338, Acts of 1947, and all Acts amendatory thereto, General Assembly of the State of Indiana:

WHEREAS, the Board of County Commissioners of Wabash County, Indiana, has caused a survey to be made with regard to the speed limit and traffic control devices on certain highways within Wabash County, Indiana, and

WHEREAS, the report of such survey is on file with the Board of County Commissioners of Wabash County, Indiana,

NOW THEREFORE, the speed limit from and after the erection of signs so indicating will be as follows: (1) 30 miles per hour on County Road 500 within the Town Limits of the Town of Lincolnville; (2) 30 miles per hour on County Road 600E within the Town Limits of the Town of Lincolnville; (3) 50 miles per hour on Wabash County Road 250S from the City Limits of the City of Wabash to Wabash County Road 600E; (4) 30 miles per hour on the road which crosses the Salamonie Dam from a point one-half mile east of the center of said Salamonie Dam to a point one-half mile west from the center of said Salamonie Dam; (5) 50 miles per hour on the Salamonie Road from Wabash County Road 250S to the east County Line

except in the vicinity of Salamonie Dam as hereinabove specified;

(6) 30 miles per hour on County Road 1100S, which is commonly known as the Old Frances Slocum Road, from State Road #13 west to where the Frances Slocum Road is closed by a permanent barricade;

(7) 30 miles per hour from a point 200 feet north to a point 200 feet south of the Mississinewa Dam and on the bridge across the Mississinewa Dam on the Mississinewa Road;

(8) 50 miles per hour on the Mississinewa Road from Wabash County Road 950S to the old Frances Slocum Trail Road with the exception of the said bridge and that portion of said Highway near the Mississinewa Dam hereinabove mentioned;

(9) 30 miles per hour on the Potterf Road from the Wabash City Limits, as of the date of this Ordinance, to State Road #24;

(10) 30 miles per hour on all streets located within the Town Limits of the Town of Disko, except for State Road #114;

(11) 30 miles per hour on ~~State~~ ^{COUNTY} Road #200E from a point five hundred feet north of the driveway from said ~~State~~ ^{COUNTY} Road #200E into the Timbercrest Church of the Brethren Home to the intersection of said Road #200E with State Road #13.

This Ordinance shall be in full force and effect from and after the erection of appropriate signs at said places.

If a part of this Ordinance is invalid, all valid parts that are severable from the invalid parts shall remain in full force and effect.
