## RESOLUTION AND ORDER #3

WHEREAS, pursuant to the terms of Acts of Indiana, 1945, Ch. 208, § 79, as amended, the Board of County Commissioners of each of the several counties of this state are charged with the duty on or before the 1st day of March, of each year to meet and rearrange its several voting precincts in the county in such a manner that the boundaries of the several voting precincts of the county in which cities are located shall be coextensive with the boundaries of such cities, and,

WHEREAS, the City of Wabash, Indiana, located in Wabash County, Indiana has, by several special ordinances, annexed land to the City of Wabash and it has, therefore, become necessary to rearrange the precincts so that the boundaries of said precincts shall be coextensive with the boundaries of the City of Wabash,

 $\mathtt{NOW}_{x}$  THEREFORE, BE IT RESOLVED as follows:

It is hereby ORDERED by the Board of County Commissioners of Wabash County, Indiana that:

- 1. All residents living within that land annexed to the City of Wabash pursuant to Special Ordinance #1, dated February 8, 1965 and containing 27.91 acres of land lying on the easterly side of North Manchester Avenue in the City of Wabash, Indiana shall henceforth vote in Noble Township, Precinct No. 3 and shall no longer vote in Noble Township Precinct No. 7. Said Noble Township Precinct No. 3 is newly constituted to contain 1,267 voters, more or less.
- 2. All residents living within that land annexed to the City of Wabash pursuant to Special Ordinance #2, dated January 28, 1965, containing 22.59 acres of land, more or less, lying on the southerly side of U. S. No. 24 By-Pass in the

City of Wabash, Indiana shall henceforth vote in Noble Town-ship, Precinct No. 5 and shall no longer vote in Noble Town-ship Precinct No. 7. Said Noble Township Precinct No. 5 is newly constituted to contain 1,354 voters, more or less.

3. All residents living within that land annexed to the City of Wabash pursuant to Special Ordinance #12, dated November 23, 1964 containing 3.506 acres of land, more or less, and lying on the western side of North Wabash Street in the City of Wabash, Indiana shall henceforth vote in Noble Township, Precinct No. 6 and shall no longer vote in Noble Township, Precinct No. 7. Said Noble Township Precinct No. 6 is newly constituted to contain 889 voters, more or less.
