GENERAL ORDINANCE # 6 WABASH COUNTY, INDIANA.

WHEREAS, the Board of County Commissioners of Wabash County, Indiana, have on the ______day of March, 1966, adopted a comprehensive Master Plan and Zoning Ordinance for Wabash County, Indiana, and,

WHEREAS, pursuant to Ch. 174, § 34 of the Acts of Indiana, 1947, as amended, said ordinance automatically operates as a zoning ordinance up to the boundaries of the City of Wabash, Indiana, and,

WHEREAS, the Plan Commission of the City of Wabash,
Indiana, has heretofore filed its petition with the Board of
County Commissioners requesting that it be permitted the
authority to exercise planning and zoning jurisdiction outside its boundaries and area contiguous to the City of Wabash,
Indiana, and,

WHEREAS, the Wabash County Plan Commission, pursuant to notice duly given did on the 1st day of September, 1965, hold a public meeting to consider the merits of said petition and have made their recommendations to the Board of County Commissioners of Wabash County, Indiana, and,

WHEREAS, the Board of County Commissioners of Wabash County, Indiana, have carefully considered the recommendations made by the Plan Commission and have made their own study and inquiry into the matter,

NOW, THEREFORE, BE IT ORDAINED AS FOLLOWS:

The Board of County Commissioners of Wabash County,

Indiana, this 24 day of May, 1966, do hereby

grant to the Plan Commission of the City of Wabash, Indiana,

the exclusive rights, powers and duties to exercise planning

and zoning jurisdiction in the following described area outside the corporate limits of the City of Wabash, Indiana, the same being bounded and described as follows, to-wit:

BEGINNING at the southwest corner of fractional Section numbered twenty-two (22) in Township twenty-seven (27) north, Range Six (6) east, thence north along the west line of said fractional Section numbered twentytwo (22) and the west line of Reserve numbered twenty-three (23) to the Wabash River; thence westwardly down said river to the north and south half Section line of fractional Section numbered Sixteen (16); thence north along said half section line and the half-section line of Section numbered Nine (9) and the half-section line of Section numbered Four (4) to the center of said Section numbered Four (4); thence east along the north line of the southeast quarter of Section numbered Four (4) to the southwest corner of the northwest quarter of Section numbered Three (3); thence north along the west line of said northwest quarter to the northwest corner thereof; thence east along the north line of said Section numbered Three (3) and the north line of Section numbered Two (2) to the center of State Road #24 By-pass; thence northeastward and eastward along said State Road #24 By-pass and State Road #24 to the range line dividing ranges six (6) and seven (7); thence south along said range line to the Dora Road; thence west along said Dora Road to the east line of Reserve numbered Nineteen (19); thence south along said east line of said Reserve numbered Nineteen (19) to the southeast corner thereof; thence west along the south line of said Reserve to the east line of Reserve numbered eighteen (18); thence south along said east line of said Reserve numbered eighteen (18) and the east line of fractional Section numbered twenty-three (23) to the southeast corner of said fractional Section; thence west to the place of beginning.

This ordinance in the rights, powers and duties conferred thereupon shall be effective as of the date of passage of the Wabash County Master Plan and Zoning Ordinance.
