t was moved by Lemione Miltenberger and second by Thomas Earl and by unanimous vote hat the Precincts set up by the Clerk be left as accepted except one exception. 'aw Paw Township will be made one Precinct instead of two. The Precincts are as follow Lagro Twp. 3, Paw Paw Twp. 1, Liberty Twp 1, Pleasant 1, and Noble Twp.

LAGRO Township shall be divided into Three Precincts as follows: LAGRO TOWNSHIP PRECINCT 1:

That part of Lagro Township lying South of a line described as follows:

Beginning at the intersection of the Mater Road extended eastward and the Wabash-Huntington County Line, thence west along the center line of the Mater Road to the intersection of the Mater Road extended westward with the American Road and the Auer Road, thence southwest along the center line of the Auer Road to the intersection of the Auer Road with the Lagro-Noble Township line.

LAGRO TOWNSHIP PRECINCT 2:

That part of Lagro Township bounded as follows:

Beginning at the intersection of the Mater Road extended eastward and the Wabash-Huntington County line, thence west along the center line of the Mater Road to the intersection of the Mater Road extended westward with the America Road and the Auer Road; thence southwest along the center line of the Auer Road to the intersection of the Auer Road with the Gillespie Road, which point is on the Lagro-Noble Township line, thence southwest and north along the Lagro-Noble Township line to the intersection of State Road No. 13 With the Speicher Road at Speicherville, thence east along the center line of the Speicher Road to the Baker Road; thence north along the center line

of the Mattern Road, thence north along the center line of the Baker Road to the Mattern Road, thence east along the center line of the Mattern Road to the Lagro-Servia Road, thence north along the center line of the Lagro-Servia Road to the Huntington Road, thence east along the center line of the Intington Road to the Wabash-Huntington County line, thence south along the Wabash-Huntington County line to the place of beginning.

LAGRO TOWNSHIP PRECINCT NO. 3:

That part of Lagro Township lying north of the Speicher-Mattern-Huntington Roads line described above as the Northern boundary of PRECINCT No. 2.

The registration cards of the voters in Lagro Township have not been re-arranged in the three new Precincts.

LIBERTY Township shall be one precinct to be known as Liberty Town-ship PRECINCT 1.

Paw Paw Township shall be divided into two Precincts as follows:

PAW PAW TOWNSHIP PRECINCT No.1:

That part of Paw Paw Township lying West of the Mount Pike.

PAW PAW TOWNSHIP PRECINCT No. 2:

That part of Paw Paw Township lying East of the Mount Pike.

This is an unequal division of Paw Paw Township. We have been told that people living in the central part of the Township will resist being sent to Urbana to vote, Perhaps after the voting machines are established at Roann and Urbana, a more equal division of the voters can be accomplished.

PLEASANT Township shall be one Precinct to be known as PLEASANT TOWNSHIP PRECINCT NO. 1.

WALTZ Township shall be one Precinct to be known as WALTZ TOWNSHIP PRECINCT No. 1.
