STATE OF INDIANA, COUNTY OF WABASH, SS:

WABASH COUNTY HIGHWAY ORDINANCE NO. 4 OF 1958.

WHEREAS, the Board of Commissioners of the County of Wabash and the County Supervisor of said County have made an engineering and traffic investigation in relation to one of the highways of said County, known as the Carr Road, running east and west approximately one mile south of and parallel to the north line of Noble Township of Wabash County, and said County officials have determined that traffic upon said Carr Road should have preference at its intersection with the Wabash-Miami County Line Road;

NOW THEREFORE, BE IT ORDAINED by the Board of Commissioners of the County of Wabash:

- Section 1. That the Carr Road in Noble Township of Wabash County be, and the same hereby is, designated as a through highway at its intersection with the County Line Road between Wabash and Miami Counties in the State of Indiana, which intersection is located at the northwest corner of Section No. 26, in Township 28 North, of Range No. 5 East, and at the south east corner of Section No. 23 in said Township and Range.
- Section 2. That said intersection be, and the same hereby is, designated as a STOP intersection for traffic approaching said intersection from the north and from the south upon the said Wabash-Miami County Line Road.
- Section 3. That appropriate STOP signs shall be erected at said intersection, as nearly as practicable at the proper right of way line of the Carr Road, and in conformity with Indiana State Highway requirements.
- Section 4. That hereafter every driver of a vehicle approaching said intersections from the north and from the south shall come to a full stop at such sign before entering such intersection.
- Section 5. This ordinance shall be published one time in the Wabash Plain Dealer and one time in the North Manchester News-Journal, both being newspapers of general circulation, printed and published in Wabash County, Indiana, and shall be in full force and effect one week after such publication.
- Section 6. Any person violating any of the provisions of this ordinance shall be guilty of a misdemeanor and shall, upon conviction, be punished by a fine of not less than Five Dollars (\$5.00) nor more than One Hundred Dollars (\$100.00) for each offense.
- Section 7. That all ordinances and parts of ordinances in conflict with this ordinance be, and the same hereby are, repealed.
