ORDINANCE # 1- 1952

TITLE: An Ordinance to make certain County Highways in Wabash County preferential Highways, defining the same and providing for the erection and maintenance of Stop Signs thereon.

BE IT ORDAINED by the duly elected and qualified Commissioners of Wabash County, State of Indiana, in regular session (all members thereof concurring), that: The following Public Highways of the County except State or Federal Highways, be declared preferential Highways, as follows:-

PREFERENTIAL ROADS IN HIGHWAY SYSTEM OF WABASH COUNTY

Wendel Road Preferential Road: From State Highway #114

North to the Wabash County Line.

Delauter Road Preferential Road: From State Highway #114

north to Wabash County Line.

Cook Road Preferential Road: From State Highway # 13

north to Wabash County Line.

Forgy Road Preferential Road: From State Highway # 114

south to Lukens Lake Laketon Road.

Ogden Road Preferential Road: From State Highway

114 South to the Lukens Lake Laketon Road .

Crill Road Preferential Road: From State Highway # 114 south to Ogden Road.

Luken Lake Laketon Road Preferential Road: From intersection of main street in Laketon west to State Highway # 15. And from State Highway # 15 west thru the intersection of the Roann Lukens Lake and Laketon Lukens Lake Roads.

LAKETON Road Preferential Road: From Main street in the Town of Laketon south to State Highway # 16; From State Highway # 16 south thru the intersection of the Carr and Laketon Roads.

Roann Lukens Lake Road Preferential Road: From the intersection of Laketon Lukens Lake and Roann Lukens Lake road south to the north town limits of Roann.

Troyer Road Preferential Road: In Section 15 and 10, Township 29, Range 6 East. From Lukens Lake Laketon road south to its end. And from Lukens Lake Laketon Road north to Woodring Road.

Shiveley Road Preferential Road: From the Town Limits of North Manchester north to State Highway # 13; and from State Highway # 13 north to the Wabash County Line.

Blickenstaff Road Preferential Road: From State Highway # 13 north to the Wabash County north line.

Martin Road Preferential Road: From State Highway # 13

east to the Wabash County east line.

Porter Road Preferential Road: From State Highway # 114

north to the Martin Road.

Lagro Servia Road Prefrential Road: From State Highway # 113 south to State Highway # 16 and from State Highway # 16 south to north town limits of the Town of Lagro.

Klutz Road Preferential Road: From State Highway # 113 east thru the intersection of the Klutz and Gibbert Roads.

Nehr Road Preferential Road: From State Highway $\frac{\#}{\#}$ 113 north to the intersection of Singer and Nehr Roads.

Singer Road Preferential Road: From State Highway # 113 south eastly thru the intersection of the Singer and Nehr Roads.

Hanley Road Preferential Road: From the Singer Road east thru the intersection of the Nehr and Hanley Roads.

Mount Road

All Traffic from the west on the Mylin road shall stop for the Mount Road.

Mylin Road

All Traffic from the north on the Mount Road shall stop at the intersection of the Mount and Mylin Roads.

Mount Road Preferential Road: From State Highway # 16 south to State Highway # 15.

Garrison Road Preferential Road: From State Highway # 13 west to Laketon Road.

Roann Richvalley Road Preferential Road: From the south town limits of Roann south to State Highway # 24.

Schuler Road Preferential Road: From the Roann Richvalley road east thru the intersection of the Schuler and Paullus Roads.

Angling Road Or Watson Road Preferential Road: The Angling road from the State Highway # 15 angling north west thru Section 18, Township 8, Range 6 East thru the intersection of said angling road and Paullus road.

Farr Pike Preferential Road: From west Wabash City limits west to State Highway # 115; and from State Highway # 115 west to Roann Richvalley Road; and from Roann Richvalley Road west to Wabash and Miami County line.

Carr Road Preferential Road: From State Highway # 15 east to Mount Road and from the LaSalle road east to State Highway # 13.

Laketon Road Traffic from the South on the Laketon road shall stop at the Carr Road.

<u>LaSalle Road</u> Preferential Road: From North Wabash City limits north thru the intersection of Carr and LaSalle Roads. Traffic from the north on LaSalle road shall stop at Carr Road.

Walnut Tree Pike Preferential Road: From the France Road south to State Highway # 124.

Wolf Road Preferential Road: From Walnut Tree Pike east to State Highway # 15; and from State Highway # 15 east thru the intersection of Wolf and Gertner Road. The Bailey road shall be a stop road at this intersection. Traffic from the east on the Wolf Road shall stop at the Gertner Road.

Mill Creek Pike Preferential Road: From the south Wabash City limits south west to State Highway # 124; and from State Highway #124 south to the Francis Slocum Trail.

Cooper Road Preferential Road: From the Mill Creek Pike North westerly thru the intersection of the Cooper and Prairie Roads.

Treaty Pike Preferential Road: From State Highway # 13 west to the Mill Creek Pike; and from Mill Creek Pike west to the Wabash County west line; and from State Highway # 13 east to State Highway # 15; and from State Highway # 15 east to LaFontaine road (Old State Highway #15)

Yankee Road Preferential Road: From the Francis Slocum Trail north thru the intersection of the Howell and Yankee Road.

The Yankee road traffic from the north and the Howell traffic from the west shall stop at this intersection of Yankee and Howell Roads.

Simmons Road Preferential Road: Simmons shall be a preferential road thru the intersection of the Simmons and LaSalle Roads.

Barnhart Road Preferential Road: The Barnhart road shall be a preferential road thru the intersection of the Barnhart and Long roads.

Francis Slocum Trail Preferential Road: From State Highway # 13 west to the Wabash County west line.

Pitts Road Preferential Road: From the Francis Slocum
Trail west to the Wabash County West line.

Pearson Mill Road Preferential Road: From State Highway # 13 east thru the intersection of the Wacacona Pike and Pearson Mill Road; Wacacona traffic from the north shall stop at the intersection of the Wacacona Pike and Pearson Mill Roads.

<u>Urbana Road</u> Preferential Road: From State Highway # 13 east to Lagro Servia Road.

Speicher Road Preferential Road: From State Highway # 13 east to Lagro Servia Road.

Porter Road Preferential Road: Porter Road shall be a preferential road thru the intersection of the Porter and Mattern Roads.

<u>Dora Road</u> Preferential Road: From LaFontaine road (Old State Highway # 15) east thru the **D**ora Covered Bridge.

Bowers Road Preferential Road: From Dora Covered Bridge east to the Bowman road Lagro Township.

American Road Preferential Road: From State Highway # 524 south to Dora Road; and from Dora Road south to State Highway # 124; and from State Highway # 124 south to the Scott Pike.

Bowman Road & Lagro Township Preferential Road: From Holland Pike north to the Hanging Rock Road.

Hanging Rock Road Preferential Road: From State Highway # 524 east
to Wabash County east line.

Waggoner Road Preferential Road: From Dora Pike to State Highway # 124; and from State Highway # 124 to Scott Pike.

New Holland Road Preferential Road: From Waggoner Road east thru the intersection of the New Holland and Bowman Roads. (Lagro Township)

Baumbauer Road Preferential Road: Baumbauer road shall be a preferential road thru the intersection of Morrison and Baumbauer Roads.

LaFontaine Road (Old State Highway # 15) Preferential Road: From Wabash City south City limits south to State Highway # 124 and from State Highway # 124 south to north town limits of LaFontaine.

<u>Wacacona Pike</u> Preferential Road: From Pearson Mill Road north to the Treaty Pike.

Crow Road Preferential Road: From west town limits of LaFontaine to Pearson Mill Road.

B runer Road Preferential Road: From intersection on Thomas road west to Troyer river bridge.

Thomas Road Preferential Road: From State Highway # 15 south thru the intersection of the Thomas and Bruner Road. Traffice from the south on the Thomas Road shall stop at the Bruner Road. Traffic from the east on the

Bruner Road shall stop at the Thomas Road.

Rudicel Road Preferential Road: From east town limits of LaFontaine east thru the intersection of Rudicel and Waggoner Roads.

Waggoner Road Preferential Road: From the Rudicel road north thru the intersection of Waggoner and Rennicker Roads. Traffic from the north on the Waggoner road shall stop at the Rennicker Road.

Rennicker Road Preferential Road: From the Waggoner road east to the Wabash County east line.

Boundry Line Road Preferential Road: From the north town limits of LaFoutaine north thru the intersection of the Boundry Line Road and Kerr Roads.

Scott Pike Preferential Road: From the Boundry Line Road east to Wabash County east line. Traffic from the west on Scott Pike shall stop at the Boundry Line Roads.

Bruner Road Preferential Road: Bruner Road shall be a preferential road thru the intersection of Bruner and Waggoner Roads.

Baumbauer Road Preferential Road: Baumbauer Road shall be a preferential road thru the intersection of the Baumbauer and Gillispie Roads.

Vernon Pike (Old State Highway # 13) Preferential Road: From
Wabash south city limits to State Highway # 13.

Marion Road (Old State Highway # 15) Preferential Road: From LaFontaine south city limits south to State Highway # 15.

Prairie Road Traffic on this road traveling south shall stop at Elliott Road.

Francis Shocum Trail Preferential Road: From State Highway # 13 east to the Wabash and Grant County Line.

Yankee Road Preferential Road: From Mill Creek Pike south to State Road # 124.

BE IT FURTHER ordained that stop signs of some suitable material be erected and maintained at the intersection of the aforesaid preferential highways with all other County Roads intersecting with said highways.

This Ordinance shall be in full force and effect immediately upon the Legal Publication thereof.
