## ORDINANCE CONTROLING MOVEMENT OF BUILDINGS UPON PUBLIC HIGHWAY

Comes now Raymond Brooks, County Attorney, upon request and files with the Board of Commissioners of Wabash County an Ordinance controling the movement of Buildings a etc upon the Highways of Wabash Co.

BE IT ORDAINED by the duly elected and qualified Commissioners of Wabash County, State of Indiana, in regular session, that:

SectionK. It shall be unlawful to move | carry, tow, haul or transport over, along and upon the county Mighways any building, structure, vehicle or other object which occupies more than one-half the width of said highway, unless said movement is authorized by the County Highway Supervisor, as hereinafter provided.

SEC. II. In the event that any person, firm or corporation is desirous of moving any object as above set forth, they shall first apply to the County Highway Supervisor for a permit to do so. Said application shall be accompanied by a deposit not to exceed sum of one hundred dollars (\$100.00).

SEC. III Upon receiving an application to move an object over, along and upon the county highway, the County Highway Supervisor shall, upon the receipt of the deposit above prescribed, issue a printed permit stipulating the conditions under which said object may be moved, the height of said object, and provisions requiring a simultaneous permission of utilities to move said object over, along and upon said highways wherever said object might contact or disturb utility transmission lines.

Sec. IV, The County Highway Supervisor or his agent or employees shall supervise the movement of said object on said highway and upon the completion of the movement and the removal of said object from the highways and the examination of the highway over which said object moved, the supervisor shall return the deposit theretofore made, less any damages than may have occured as a result of the moving of said object over, along and upon the county highways.

SEC. V. In the event any object being moved over, along and upon the county highways shall become stalled and/or permitted to stand on said highway more than 24 hours, the c County Highway Supervisor shall remove said object from the travelled portion of said highway at the expense of the permittee and the expense thereof shall be deducted from the deposit theretofore made.

SEC. VI. Any person, firm or corporation found guilty of violating the provisions of this ordinance shall, upon conviction thereof, be fined in a sum of not to exceed two hundred dollars (\$200.00).

Whereas, the Commissioners declare an emergency to exist, this ordinance shall be in full force and effect immediately upon the publication thereof.
