LEGAL

ALLEYS LOCATED IN P. & E. WERTENBERGER'S ADDITION TO THE TOWN OF LAKETON AS FOLLOWS:

10 FOOT WIDE ALLEY

BEGINNING AT SOUTHWEST CORNER OF LOT 28 AND GOING EAST PARALLEL WITH SOUTH LINE OF LOT 28 AND LOT 27 TO SOUTH EAST CORNER OF LOT 27. THEN SOUTH TO THE NORTH EAST CORNER OF LOT 22. THEN WEST PARALLEL WITH THE NORTH LINE OF LOT 22 AND 21 TO THE NORTH WEST CORNER OF LOT 21. THEN NORTH TO THE POINT OF BEGINNING.

ALSO

10 FOOT WIDE ALLEY

BEGINNING AT SOUTHWEST CORNER OF LOT 20 AND GOING EAST PARALLEL WITH SOUTH LINE OF LOT 20 AND LOT 19 TO SOUTH EAST CORNER OF LOT 19. THEN SOUTH TO THE NORTH EAST CORNER OF LOT 14. THEN WEST PARALLEL WITH THE NORTH LINE OF LOT 14 AND 13 TO THE NORTH WEST CORNER OF LOT 13. THEN NORTH TO THE POINT OF BEGINNING.

ALSO

16 FOOT WIDE ALLEY

BEGINNING AT SOUTHEAST CORNER OF LOT 12 AND GOING NORTH PARALLEL WITH THE EAST LINE OF LOTS 12, 13, 20, 21 AND 28 TO NORTHEAST CORNER OF LOT 28. THEN EAST TO THE NORTHWEST CORNER OF LOT 27. THEN SOUTH PARALLEL WITH THE WEST LINE OF LOTS 27, 22, 19, 14, AND 11 TO THE SOUTHWEST CORNER OF LOT 11 THEN WEST TO THE POINT OF BEGINNING.
