**AN ORDINANCE VACATING A PORTION OF A 10 FT WIDE ALLEY
AS IDENTIFIED IN THE LEGAL DESCRIPTION BELOW, ORIGINAL PLAT
OF THE TOWN OF LAKETON, WABASH COUNTY, INDIANA**

One group of (1) freeholders of Wabash County, IN filed a petition to vacate a portion of
the 10 Ft wide and 16 Ft wide alleys in the Original Plat of the Town of Laketon

On October 22, 2018 as required by law and following proper notification to
abutting property owners and publication of notice, a public hearing was held on said petition.

The Board of Commissioners of Wabash County, Indiana determined that the request to
vacate certain alleys of the Original Plat of Laketon

as outlined in the following legal description, should be approved as requested.

Legal Description

THE 10 FT WIDE ALLEY LOCATED BETWEEN LOTS 32 & 33 AND LOTS 31 & 34
IN THE ORIGINAL PLAT OF THE TOWN OF LAKETON AND THE 16 FT WIDE
ALLEY LOCATED BETWEEN LOTS 17 & 18, LOTS 31 & 32, LOTS 33 & 34, AND
LOTS 47 & 48 IN THE ORIGINAL PLAT OF THE TOWN OF LAKETON,
PLEASANT TOWNSHIP, WABASH COUNTY.
PER PLAT BOOK # 2 - PAGES 75 AND 76

IS NOW HEREBY VACATED.
