

# eCWS iPad Equipment Specifications

The electronic-Citation and Warning System (eCWS) for iOS requires an iPad (7<sup>th</sup> Gen), iPad Air 2, or iPad Mini(4 or higher). With these devices, IOCT highly recommends that agencies acquire the appropriate scanner for their acquired iPad model, from Tab M Series made by Infinite Peripheral. The scanner allows officers to scan information from the offender driver's license and registration. Please refer to the information below for equipment specifications:

# iOS Minimum Requirements:

The following information is the minimum requirements for an iOS device to properly run the eCWS application. Most iPad Tablets that can run iOS 14 or higher should be able to install and run eCWS.

## Mobile Printers:



<u>Currently, the only printers that will work with the eCWS iPad application are the</u> <u>Zebra ZQ520</u>, Brother RuggedJet 4230, and the Brother PocketJet 763 (8.5x11 paper)

**Paper:** The Zebra and Brother RuggedJet Printers use a standard 8000D 3.2 Mil High-Temp Receipt Paper, while the PocketJet uses standard paper



**iPad Scanners** – Scanners from Infinite Peripherals are the only approved scanners for use with the eCWS iPad application. This company also produces the specialty case that both holds the scanner on the iPad, and helps to protect the iPad. This company makes different scanners for each iPad model. Please ensure the scanner/case combo ordered is the proper scanner for the iPad model being used.
