In accordance with Trial Rule 81 of the Indiana Court Rules, the Adams Circuit and Superior Courts hereby give notice to the bar and the public that the Courts propose to amend the Local Rule(s) on mental health court fees for the courts of record of Adams County.

Notice has been given to the public by posting on the website of the Adams County Clerk and at the Indiana Judiciary webpage for Local Rules (<https://www.in.gov/courts/publications/local-rules/>), and by furnishing a copy to the officers of the Adams County Bar Association. A paper copy of the proposed amended local rule is available for viewing in the Office of the Clerk of Adams County, 112 S. 2nd Street C, Decatur, Indiana 46733 during normal business hours.

The time period for the bar and the public to comment on the proposed rule changes shall begin on August 1, 2024, and shall close on September 3, 2024. The proposed amendments to the rule will be adopted, modified, or rejected before September 20, 2024, and the request to revalidate the existing caseload allocation will be submitted to the Indiana Supreme Court for review and approval with an effective date of January 1, 2025.

LR01-A400-02 PROBLEM-SOLVING COURTS

Those persons directed to participate in the Adams County Resilience Court shall be assessed in accordance with the following Schedule of Fees pursuant to the authority granted by the Indiana Problem Solving Courts Statutes (Indiana Code 33-23-16-16 et.al.) and the Indiana Problem-Solving Court Rules:

1. A Resilience Court administrative fee of one hundred dollars (\$100.00) per participant payable to Adams County Community Corrections.
2. A Resilience Court user fee of fifty dollars (\$50.00) per month, beginning the first month of participation for every month that an individual participates in Resilience Court, payable to Adams County Community Corrections.
3. A Resilience Court chemical testing fee often dollars (\$10.00) for negative results payable to Adams County Community Corrections.
4. A Resilience Court chemical testing confirmation fee ranging from thirty-five dollars (\$35.00) to fifty dollars (\$50.00) per substance tested 12 payable to Adams County Community Corrections.
5. Substance use disorder services, mental health services, and general health services as set by the providers and payable to the entity providing the service.
6. Program fees such as Moral Reconciliation Therapy (MRT), one hundred dollars (\$100.00) payable to Adams County Community Corrections.
7. Fees due to sanctions, such as:
  - a. Home Detention/electronic monitoring at a cost ranging from fourteen dollars (\$14.00) to seventeen (\$17.00) payable to Adams County Community Corrections.
  - b. Work Release at a cost of:
    - i. Initial Processing fee of twenty-five dollars (\$25.00), payable to the Adams County Clerk
    - ii. Administrative and Advance fee of three hundred thirty-six dollars (\$350.00), payable to the Adams County Detention Center; and
111. Room and Board and GPS Monitoring fee of one hundred sixty-eight dollars (\$175.00) per week (at a minimum) commencing the second week of Work Release, payable to the Adams County Detention Center.
8. Transfer fee of one hundred dollars (\$100.00) when individuals are transferring in or out of Adams County, payable to Adams County Community Corrections.
