Order Appointing Senior Judges and Allocating Senior Judge Service Days

Administrative Rule 5(B)(1) authorizes the Indiana Supreme Court to appoint all senior judges certified by the Judicial Nominating Commission to serve in the Court of Appeals, the Tax Court, a circuit, a superior, or a probate court.


IT IS, THEREFORE, ORDERED that all senior judges certified by the Judicial Nominating Commission for service in 2025 are appointed to serve in the Court of Appeals, the Tax Court, or any circuit, superior, or probate court during 2026.

Additionally, Administrative Rule 5(B)(2) provides that the Supreme Court shall annually fix the number of senior judge days each court may use, based on the recommendation of the Court's Chief Administrative Officer, using the weighted caseload measurement system and other relevant criteria, including committee and Judicial Conference assignments, prior usage, and medical needs.

Senior judges are an important resource available to trial court judges to manage their caseloads and can be utilized in a variety of ways. Senior judges can cover the docket while the trial judge handles administrative matters, such as writing orders and handling tasks associated with staff management. Senior judges can also help cover the docket when trial judges are attending training or committee meetings. And senior judges are available to be appointed as special judges. Any court needing additional days to implement plans to utilize senior judges for case backlogs or for handling conflicts as special judges should contact the Office of Judicial Administration as explained below.

Requests for Additional Days. The burden is on the trial court judge to ensure that their use of senior judge days does not exceed their annual allotment as specified in the attached spreadsheet. The Senior Judge Portal provides up-to-date data on senior judge day usage for each court. The Court encourages judges to make use of these resources to track their usage of senior judges.

The practice of exceeding a court's senior judge allotment without first seeking additional days should be avoided whenever possible. **Unless exceptional circumstances prevent doing so, requests for additional days must be submitted prior to the court exceeding its annual allotment. Requests for additional senior judge service days made after the court's allotment**



has already been exceeded may be denied. Judges wishing to request additional allotments must contact Akash Burney (akash.burney@courts.in.gov), in writing, and provide detailed information on new or changed circumstances necessitating additional senior judge service days. Additional allotments will not be made before March 1, 2026, unless an urgent need is demonstrated.

Coverage of Suspensions. Senior judges may be used to cover suspensions that occur because of disciplinary action. It is the suspended judge's responsibility to coordinate coverage of their suspension. It is also the suspended judge's responsibility to ensure that their court has the requisite number of senior judge days to cover the suspension and to request additional days if necessary to cover the entirety of their suspension. A suspended judge will be required to use any remaining senior judge days from their 2026 allocation before being granted additional days to cover a suspension. Additional days will then be granted, upon request, to cover the remainder of the suspension. The Court will not automatically grant requests for additional senior judge days for vacation or other personal matters that follow a suspension.

Judicial Conference Annual Meeting. Pursuant to Indiana Code section 33-38-9-3, senior judges are members of the Judicial Conference of Indiana. **During the Annual Meeting of the Judicial Conference, senior judges are asked to prioritize assisting active Judicial Conference members by covering their courtrooms to allow those judicial officers to attend the Annual Meeting.** If, however, a senior judge is not covering court for another Judicial Conference member, then their attendance at the Annual Meeting is expected. Senior judges who attend will receive mileage reimbursement and senior judge credit for their attendance.

Senior Judge Portal. The Senior Judge Portal is available via the INcite application. The Portal can be accessed by logging into INcite. Once logged in, the Portal should appear on the right-hand side of the dashboard. The Portal contains a profile providing contact information, experience, and preferences for each senior judge. If the Portal does not appear on your INcite account, please contact Akash Burney (akash.burney@courts.in.gov).

IT IS, THEREFORE, FURTHER ORDERED that each court may use the number of senior judge days specified in the attached spreadsheet without any additional request to this Court. In those counties with unified courts and authority vested in the chief judge to allocate senior judge service days, the total number of senior judge service days allocated to the unified courts may be assigned by the chief judge to the various courts without reference to the limitations imposed upon individual courts by this Order. Such reassessments of senior judge service days shall be reported to the Chief Administrative Officer by emailing Akash Burney (akash.burney@courts.in.gov).

IT IS FURTHER ORDERED that the Court of Appeals and the Tax Court may utilize such senior judge service days as reasonably necessary to conduct the business of those courts.
