II. Old Business

- a. Recently proposed ADR Rule amendments:
 - i. All amendments proposed by this committee, other than Rule 1.5, are currently under review.
 - ii. Angela Reid-Brown confirms the Rules Committee tabled further review of the proposed amendments to the ADR rules while the Civil Litigation Task Force, through its own ADR workgroup, review the ADR Rules. The Civil Litigation Task Force is working on a report for the court that is due at the end of the year. Further review will likely not occur until sometime early next year.
- b. Indiana Rule for Alternative Dispute Resolution rule 1.5:
 - Rules Committee did not advance ADR Committee proposed amendment to rule
 1.5. Instead, Rules Committee placed the parenting coordinator immunity provision in the Indiana Parenting Time Guidelines.
 - ii. Immunity for parenting coordinators was included in the Order Amending Indiana Parenting Time Guidelines filed October 5, 2021.
 - iii. Effective January 1, 2022: Section V. Parenting Coordination, Part B. Qualifications, is amended as follows: "The Parenting Coordinator shall be a registered Indiana Domestic Relations Mediator, with additional training or experience in parenting coordination satisfactory to the court making the appointment. A Parenting Coordinator, as a registered Indiana Domestic Relations Mediator under ADR Rule 1.5, has immunity in the same manner and to the same extent as a judge."
- c. Online Dispute Resolution:

- i. Lake County pilot court for small claims ODR: No stats or data available yet but there has been some level of success and participation is good.
- ii. Monroe, Vigo, and Marion Co. are all trying to start family law ODR programs. It has been slow to launch largely due to development and implementation roadblocks.

III. New Business

- a. Eviction Facilitation/Settlement conference updates:
 - i. Pre-eviction diversion program was recently announced by the IN Supreme Court and is presently in effect.
 - ii. Most of the committee feels the new program doesn't have adequate motivation for the landlord to participate.
 - iii. Disincentives for the landlords: 90 days is too long, multiple hearings, confidentiality issues, etc.
 - iv. Some large landlords are switching to land contracts and rent-to-own models to sidestep renter protections.
 - v. Eviction FastTrack facilitation program is separate and still ongoing.
- b. Discussion regarding Domestic Relations Mediator qualifications:
 - i. Why don't DR Mediators have to be attorneys, as opposed to traditional mediators?
 - ii. After some preliminary discussion, committee agrees to return to this as a point for future discussion and information gathering.
- c. Introductions of new IOCS staff support attorney and recognition of Angela Reid-Brown's work with the committee.
