This guide will help you determine which case type to use when starting a new case based on the case category and the specific action.

NOTES

The chart indicates which case types are available for initial and/or subsequent e-filing. This only applies in counties that have e-filing available. See <u>courts.in.gov/efile</u>.

There are some actions in which no court case is needed. These include:

- 1. Department of Labor warrants: IC 22-8-1.1-35.7, no case filing needed; as of April 2014, Dept. of Labor can now file judgments through INcite
- 2. Department of Workforce Development warrants: IC 22-4-29-6, as of 10/1/15, no case needed to file/track
- 3. Governor's warrants
