

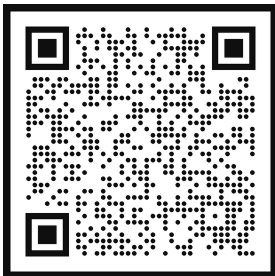
Enforcing and Modifying Parenting Time

What is Parenting Time

Parenting Time is the time a parent spends with his or her child.

About the Parenting Time HelpLine

The Parenting Time HelpLine is a service of the Indiana Department of Child Services Child Support Bureau.

The HelpLine is staffed by licensed Indiana attorneys who provide legal education and information about parenting time in Indiana. The HelpLine's services are free.

HelpLine Attorneys:

- Cannot represent your child in court
- Cannot discuss your child's case, DCS case or custody matters

Court Order for Parenting Time



Parenting time orders can be established in a court case, such as: a paternity case, a divorce case or a guardianship involving a minor. This can be done in several ways depending on if the parents agree or not.

When Parents Agree

- Parents may file an agreement with the court that includes a parenting time plan, which represents the best interest of the child(ren).
- The agreement should specifically state the terms of the parenting time schedule and may contain provisions from the Indiana Parenting Time Guidelines.
- The parenting time plan becomes enforceable when the judge approves it.



When Parents Don't Agree

- Either party can request a hearing from the court to have a judge establish a parenting time plan that becomes enforceable when the judge issues the order.
- There may be forms that can assist parents with parenting-time conflicts or making changes to a parenting-time plan. The forms are not a substitute for legal advice. You may find it helpful to seek the advice of legal counsel before using the forms. If you choose to represent yourself, www.Indianalegalhelp.org hosts helpful forms and resources to assist you.
