# Active Residential Licenses

**Purpose**  
Displays residential resources with active licensing and the related information needed to effectively administer them.  
The user is allowed to change the display using the parameter, Display For Fire And Safety Inspection, as described below.

**Population** - Resources.

**Parameters**  
**Display For Fire And Safety Inspection** - Works like a toggle switch.

- When **'Yes'** - The display is sorted by **County Name**, then **Zip** order. It shows **Address**, **Zip**, and **Phone** while **Worker Name** and **Supr Name** are removed and the heading is augmented to show the purpose as for inspections. The sorting sequence is by County Name and Zip Code.
- When **'No'** - The display is sorted by EFF End Dt order. It shows **Worker Name** and **Supr Name** while **Address**, **Zip**, and **Phone** are removed. The sorting sequence is dependent on the parameter **Resource Type**.  
If the parameter **Resource Type** is 'All' the data is sorted by Effective End Date (**Eff End Dt**).  
Otherwise it is by **County Name**, then **Resource Name**.

**Resource Type** - Facilitates communication of resource to the Web Master for display on the web site.

- Allows the user to list only the type of resources selected.

Note: When the **Display For Fire And Safety Inspection**= 'Yes', then 'Licensed Child Placing Agency – Adoption Homes Only' and 'Licensed Child Placing Agency – Foster Family Homes Only' are not available. Only 'Licensed Child Placing Agency - All' can be used

**Column Definitions**

- County** - The county in which the resources is located.
- Resource** - Each column under this group heading defines the basic resource information.
  - Type** - Self-explanatory.
  - Name**- Self-explanatory.
  - ID** - Self-explanatory.
  - Eff Str Dt** - Effective start date of the resource.
  - Eff End Dt** - Effective end date of the resource.
  - Qtr** - The quarter in which the effective end date occurs within.
  - Address** - Self-explanatory. This is not sortable. Displayed only when the parameter, Display For Fire And Safety Inspection, is 'Yes'.
  - Zip** - Self-explanatory. Displayed only when the parameter, Display For Fire And Safety Inspection, is 'Yes'.
  - Phone** - Self-explanatory. Displayed only when the parameter, Display For Fire And Safety Inspection, is 'Yes'.
- Long Term (LTC)** - Each column under this group heading regarding long term care resources as applicable.
  - Cap App** - Capacity approved.
  - Frm Age** - Beginning age of children in care.
  - To Age** - Ending age of children in care.
  - Gender** - Self-explanatory.
- Emergency Shelter (ESC)** - Each column under this group heading regarding emergency shelter care resources as applicable.
  - Cap App** - Capacity approved.
  - Frm Age** - Beginning age of children in care.
  - To Age** - Ending age of children in care.
  - Gender** - Self-explanatory.
- Worker Name** - Self-explanatory. Displayed only when the parameter, Display For Fire And Safety Inspection, is 'No'.
- Supr Name** - Self-explanatory. Displayed only when the parameter, Display For Fire And Safety Inspection, is 'No'.
